A BILL FOR AN ACT

RELATING TO THE PRESERVATION OF HONEY BEE COLONIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that pollination by honey
- 2 bees is a vital part of agricultural production. One-third of
- 3 the food produced in North America and nearly ninety-five
- 4 varieties of fruits and other foods rely on pollination by honey
- 5 bees.
- 6 The legislature further finds that since Hawaii cannot
- 7 import honey bees, the State must protect the existing honey bee
- 8 population by preventing the intentional extermination of honey
- 9 bee colonies.
- 10 The purpose of this Act is to prohibit pest control
- 11 operators from exterminating honey bee colonies that can be
- 12 safely removed and transported to a different location.
- 13 SECTION 2. Chapter 460J, Hawaii Revised Statutes, is
- 14 amended by adding a new section to be appropriately designated
- 15 and to read as follows:
- 16 "\$460J- Honey bee extermination. (a) Prior to
- 17 eliminating or terminating any honey bee colony, a pest control
