A corporation may adopt rules to prohibit tenant 5 6 shareholders, guests, and all other persons from smoking, including but not limited to electronic cigarettes, in dwelling 7 units, common elements, or limited common elements of the 8 9 corporation." SECTION 2. Section 514B-105, Hawaii Revised Statutes, is

- 12 "(b) [Unless otherwise permitted by the declaration, 13 bylaws, or this chapter, an] An association may adopt rules [and regulations] that affect the use of or behavior in units that 14 may be used for residential purposes only to: 15
- (1) Prevent any use of a unit [which] that violates the 16 declaration or bylaws; 17
