A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that sexuality health
2	education promotes healthy attitudes on adolescent growth and
3	development, body image, gender and sexuality, dating,
4	relationships, and family. The legislature also finds that
5	sexuality health education should positively affect adolescent
6	behavior and provide teens with the information, skills, and
7	support they need to develop positive values, make healthy
8	decisions, and respect the important role that sexuality plays
9	throughout a person's life. Within the past few years, several
10	states, including Hawaii, have enacted laws that require school
11	districts that teach sexuality health education to include age
12	appropriate, medically accurate health education. The
13	legislature finds that the effectiveness of sexuality health
14	education in Hawaii's schools could be bolstered by providing
15	clearer guidance on a comprehensive approach to sexuality health
16	education, greater flexibility in the implementation of the
17	curricula, and greater public access to the curricula

1	The	purpose of this Act is to:
2	(1)	Specify additional elements of Hawaii's existing
3		sexuality health education law and implementation of
4		the instruction;
5	(2)	Require the department of education to provide
6		information on the curricula to the public; and
7	(3)	Allow parents to request that their children not
8		receive the sexuality health education provided
9		pursuant to Hawaii's sexuality health education law.
10	SECT	ION 2. Section 321-11.1, Hawaii Revised Statutes, is
11	amended t	o read as follows:
12	"[+]"	§321-11.1[+] Medically accurate sexuality health
13	education	. (a) Sexuality health education programs funded by
14	the State	shall provide medically accurate and factual
15	informati	on that [is]:
16	(1)	<u>Is</u> age appropriate [and includes];
17	(2)	Includes education on abstinence, contraception, and
18		methods of disease prevention to prevent unintended
19		pregnancy and sexually transmitted disease, including
20		human immunodeficiency virus [-];

1	(3)	Helps students develop relationships and communication
2		skills to form healthy relationships that are based on
3		mutual respect and affection and free from violence,
4		coercion, and intimidation;
5	(4)	Helps students develop skills in critical thinking,
6		problem solving, decision making, and stress
7		management to make healthy decisions about sexuality
8		and relationships; and
9	(5)	Encourages students to communicate with their parents,
10		guardians, and other trusted adults about sexuality
11		and intimate relations.
12	(b)	Beginning with the 2016-2017 school year, each public
13	elementar	y, middle, intermediate, high, and alternative school
14	operated	by the department of education shall provide sexuality
15	health ed	ucation described under subsection (a).
16	<u>(c)</u>	At their own discretion, teachers may answer in good
17	faith any	question initiated by a student or students that is
18	reasonabl	y related to and consistent with the material of a
19	course pr	ovided pursuant to subsection (a).

1	(d) The department of education may eliminate or modify
2	components of instruction under subsection (a)(2) in elementary
3	school for reasons of age appropriateness.
4	(e) Sexuality health education under subsection (a) shall
5	not discriminate on the basis of sex, race, ethnicity, national
6	origin, disability, religion, sexual orientation, or gender
7	identity.
8	(f) The department of education shall develop, maintain,
9	and make available to the public a current list of sexuality
10	health education curricula that are consistent with the
11	requirements under subsection (a).
12	(g) A student shall be excused from any part of the
13	instruction provided pursuant to this section only upon the
14	written request of the student's parent or legal guardian. A
15	student may not be subject to disciplinary action, academic
16	penalty, or other sanction if the student's parent or legal
17	guardian requests that the student not receive the instruction
18	provided under this section.
19	(h) The department of education shall establish minimum
20	education and training qualifications for sexuality health
21	education teachers.

1 [-(b)-] (i) For the purposes of this section: "Age appropriate" means suitable to a particular age or age 2 group based on developing cognitive, emotional, and behavioral 3 4 capacity typical for that age or age group. "Factual information" means medical, psychiatric, 5 psychological, empirical, or statistical information that is 6 verified or supported by research conducted by recognized 7 medical, psychiatric, psychological, and public health 8 9 professionals or organizations. "Medically accurate" means verified or supported by 10 research conducted in compliance with accepted scientific 11 methods and recognized as accurate and objective by professional 12 organizations and agencies with expertise in the relevant field, 13 such as the federal Centers for Disease Control and Prevention, 14 the American Public Health Association, the American Academy of 15 Pediatrics, and the American College of Obstetricians and 16 17 Gynecologists. "Sexuality health education" means education in any medium 18 regarding human development and sexuality, including education 19 on pregnancy, family planning, and sexually transmitted 20

diseases."
