### A BILL FOR AN ACT

RELATING TO SHOOTING RANGE PROTECTION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 The legislature finds that shooting ranges in 2 this state serve as valuable resources for target shooting and firearm safety training. Shooting ranges and target shooting 3 4 facilities are important public recreation resources and provide 5 opportunities for law enforcement agencies and personnel to 6 maintain necessary firearms skills training at minimal cost. The 7 continued existence and viability of shooting ranges is impacted 8 by burdensome retroactive regulation and lawsuits, threatening 9 the availability of vital firearms training to local law 10 enforcement agencies, hunters, and the general public. 11 SECTION 2. Chapter 34, Hawaii Revised Statutes, is amended 12 by adding a new section to be appropriately designated and to 13 read as follows: 14 "\$134-Shooting Range Protection (a) Notwithstanding 15 any other provision of law, a person who operates or uses a 16 sport shooting range in this state shall not be subject to civil 17 liability or criminal prosecution in any matter relating to

- 1 a shooting range in compliance with applicable noise control
- 2 laws or ordinances established after to the date of initial
- 3 construction or operation of the range.
- 4 (b) A person who operates or uses a shooting range is not
- 5 subject to an action for nuisance and no court of the state
- 6 shall enjoin the use or operation of a range on the basis of
- 7 noise or noise pollution, if the range is in compliance with any
- 8 noise control laws or ordinances established on or prior to the
- 9 date of initial construction or operation of the range.
- 10 (c) Rules adopted by any state department or agency for the
- 11 purpose of limiting noise decibel levels that may occur in the
- 12 outdoor atmosphere do not apply to a shooting range exempted
- 13 from liability under this section.
- 14 (d) A person who acquires title to or who owns real property
- 15 adversely affected by the use of property with a permanently
- 16 located and improved shooting range shall not maintain a
- 17 nuisance action against an individual who owns the range to
- 18 restrain, enjoin, or impede the use of the range where there has
- 19 not been a substantial change in the nature of the use of the
- 20 range.
- 21 (e) Any sport shooting range that is lawfully operated pursuant
- 22 to existing law at the time of enactment of an ordinance shall

- 1 be permitted continued operational use of the shooting range
- 2 despite nonconformance to new ordinance or amendment to an
- 3 existing ordinance.
- 4 (f) A person who participates in sport shooting at a shooting
- 5 range accepts the risks associated with the sport to the extent
- 6 the risks are obvious and inherent. Those risks include, but are
- 7 not limited to, injuries that may result from noise, discharge
- 8 of projectile or shot, malfunction of sport shooting equipment
- 9 not owned by the shooting range, natural variations in terrain,
- 10 surface or subsurface, whether conditions, bare spots, rocks,
- 11 trees, and other forms of natural growth or debris.
- 12 (g) Except as otherwise provided in this section, this section
- 13 does not prohibit local government from regulating the location
- 14 and construction of a shooting range after the effective date of
- 15 this section.
- 16 (h) As used in this section "local government" means a county,
- 17 city, or town. "Shooting range" or "range" means an area
- 18 designed and operated for the use of firearms, rifles, shotguns,
- 19 pistols, silhouettes, skeet, trap, black powder, or any other
- 20 similar sport shooting."
- 21 SECTION 4. New statutory material is underscored.
- 22 SECTION 5. This Act shall take effect on July 1, 2015.
