## A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR THE ADULT PROTECTIVE AND COMMUNITY SERVICES BRANCH.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. There is appropriated out of the general 2 revenues of the State of Hawaii the sum of \$ or so much 3 thereof as may be necessary for fiscal year 2015-2016 and the sum of \$ or so much thereof as may be necessary for 5 fiscal year 2016-2017 to fund two full-time equivalent permanent 6 child/adult protective services specialist positions (2.0 FTE) 7 to investigate reports of vulnerable adult abuse or neglect in the adult protective and community services branch, Oahu 8 9 section, adult protective services program. 10 The sums appropriated shall be expended by the department 11 of human services for the purposes of this Act. 12 SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so much 13 14 thereof as may be necessary for fiscal year 2015-2016 and the 15 sum of \$ or so much thereof as may be necessary for fiscal year 2016-2017 to fund one full-time equivalent permanent 16

- 7 SECTION 7. This Act shall take effect on July 1, 2015.
