## A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR THE ADULT PROTECTIVE AND COMMUNITY SERVICES BRANCH.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$ or so
- 3 much thereof as may be necessary for fiscal year 2015-2016 and
- 4 the sum of \$ or so much thereof as may be necessary
- 5 for fiscal year 2016-2017 to fund two full-time equivalent (2.0
- 6 FTE) permanent child/adult protective services specialist
- 7 positions to investigate reports of vulnerable adult abuse or
- 8 neglect in the adult protective and community services branch,
- 9 Oahu section, adult protective services program.
- 10 The sums appropriated shall be expended by the department
- 11 of human services for the purposes of this Act.
- 12 SECTION 2. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$ or so
- 14 much thereof as may be necessary for fiscal year 2015-2016 and
- 15 the sum of \$ or so much thereof as may be necessary
- 16 for fiscal year 2016-2017 to fund one full-time equivalent (1.0
- 17 FTE) permanent general professional III position to provide



- 1 financial review, analysis, and support for the adult protective
- 2 and community services branch, Oahu section, adult protective
- 3 services program.
- 4 The sums appropriated shall be expended by the department
- 5 of human services for the purposes of this Act.
- 6 SECTION 3. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$ or so
- 8 much thereof as may be necessary for fiscal year 2015-2016 and
- 9 the sum of \$ or so much thereof as may be necessary
- 10 for fiscal year 2016-2017 to fund two full-time equivalent (2.0
- 11 FTE) permanent assistant program administrator V positions to
- 12 provide support for the adult protective and community services
- 13 branch, program development office, adult protective services
- 14 program.
- 15 The sums appropriated shall be expended by the department
- 16 of human services for the purposes of this Act.
- 17 SECTION 4. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$ or so
- 19 much thereof as may be necessary for fiscal year 2015-2016 and
- 20 the sum of \$ or so much thereof as may be necessary
- 21 for fiscal year 2016-2017 to fund three full-time equivalent

- 1 (3.0 FTE) permanent child/adult protective services specialist
- 2 positions for the Oahu adult intake unit, to provide statewide
- 3 intake functions to the adult protective and community services
- 4 branch.
- 5 The sums appropriated shall be expended by the department
- 6 of human services for the purposes of this Act.
- 7 SECTION 5. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$ or so
- 9 much thereof as may be necessary for fiscal year 2015-2016 and
- 10 the sum of \$ or so much thereof as may be necessary
- 11 for fiscal year 2016-2017 to fund two full-time equivalent (2.0
- 12 FTE) permanent registered nurse IV positions to provide nursing
- 13 support for adult protective services investigations in the
- 14 adult protective and community services branch, West Hawaii and
- 15 Kauai sections.
- 16 The sums appropriated shall be expended by the department
- 17 of human services for the purposes of this Act.
- 18 SECTION 6. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$ or so
- 20 much thereof as may be necessary for fiscal year 2015-2016 and
- 21 the sum of \$ or so much thereof as may be necessary

- 1 for fiscal year 2016-2017 to fund one full-time equivalent (1.0
- 2 FTE) permanent program specialist III position to provide
- 3 program support in Maui county for the foster grandparent
- 4 program and senior companion program.
- 5 The sums appropriated shall be expended by the department
- 6 of human services for the purposes of this Act.
- 7 SECTION 7. Notwithstanding any law to the contrary, the
- 8 department of human services shall be authorized to extend the
- 9 federal ceiling to fund the positions allocated in this Act and
- 10 to increase the federal money made available for the purposes of
- 11 this Act.
- 12 SECTION 8. This Act shall take effect on July 1, 2015.
