BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

The Federal Workforce Innovation and 2 Opportunity Act (WIOA), adopted by the United States Congress 3 and signed into law by President Barack Obama on July 22, 2014, 4 is bipartisan legislation that will improve our nation's 5 workforce development system and help put Americans back to work. 7	shall not apply to the workforce advisory boards established
8	pursuant to this section.
9	(b) The director or the director's designee shall serve as
10	the chairperson of any workforce advisory board.
11	(c) The director may designate the membership of the
12	workforce advisory boards, and the members shall be selected on
13	the basis of their knowledge, experience, and expertise. The
14	members may consist of partners, stakeholders, educators,
15	practitioners, and employers in important or emerging businesses
16	or industries that have been identified in the State.
17	(d) The workforce advisory boards shall:
18	(1) Coordinate and align workforce programs and develop
19	strategies to meet worker and employer needs;
