

### A BILL FOR AN ACT

RELATING TO THE ENVIRONMENT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that albizia, Falcataria 1 2 moluccana, is an invasive species that presents an increasingly costly threat to the economy, critical infrastructure, and 3 public safety on Hawaii island. The pre-planned removal of each 4 albizia tree costs significantly less than the combined direct 5 6 and indirect costs of removal if and when it falls into a road, power line, or building. The likelihood of albizia trees 7 falling and the long distances between residential areas and 8 9 emergency services add significantly to the uncertainty of emergency response capability, resulting in the potential loss 10 of property and human life following a hurricane. Such 11 circumstances were evident in 2014 following tropical storm 12 13 Iselle. Despite the storm never reaching hurricane strength,
- falling albizia trees caused a majority of the damage to power lines and property on Hawaii island.
- 16 The legislature further finds that the Hawaii invasive
- 17 species council and the Big Island Invasive Species Committee, a

- 1 voluntary partnership of private citizens, community
- 2 organizations, businesses, land owners, and government agencies,
- 3 have demonstrated the effectiveness and necessity of a
- 4 coordinated approach to controlling the growth and spread of
- 5 albizia trees. Their work has led to a coordinated management
- 6 plan and the development of a list of priority projects,
- 7 including the removal of hazardous albizia trees from high
- 8 priority roads and transmission lines, chemical control of all
- 9 non-hazardous trees adjacent to where hazardous albizia trees
- 10 have been removed, and community outreach. The priority
- 11 projects identified are based on the number of residents served,
- 12 availability of alternate access routes, and the long-term, most
- 13 cost-effective approach to mitigating albizia impacts.
- 14 The purpose of this Act is to appropriate funds for the
- 15 Hawaii invasive species council to coordinate the management and
- 16 removal of albizia trees that threaten access to critical
- 17 emergency services and transportation routes.
- 18 SECTION 2. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$2,100,000 or so much
- 20 thereof as may be necessary for fiscal year 2015-2016 and the
- 21 same sum or so much thereof as may be necessary for fiscal year

- 1 2016-2017 for the Hawaii invasive species council to coordinate
- 2 the management and removal of albizia trees that threaten access
- 3 to critical emergency services and transportation routes.
- 4 The sums appropriated shall be expended by the department
- 5 of land and natural resources for the purposes of this Act.
- 6 SECTION 3. This Act shall take effect on July 1, 2015.
