### A BILL FOR AN ACT

RELATING TO THE SELECTIVE SERVICE REGISTRATION AWARENESS AND COMPLIANCE ACT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature recognizes that sufficient
- 2 armed strength must be achieved and maintained to insure the
- 3 security of the United States. In a free society, the
- 4 obligations and privileges of serving in the armed forces and
- 5 the reserve components should be shared in accordance with a
- 6 system of selection that is fair and just, and consistent with
- 7 maintaining an effective national economy.
- 8 The legislature finds that to achieve these national
- 9 security goals, the United States Congress has enacted the
- 10 United States Military Selective Service Act (50 U.S.C. App. 451
- 11 et seq.), which requires all male citizens and males residing in
- 12 the United States, except for lawfully admitted non-immigrants,
- 13 to register with the Selective Service System upon reaching the
- 14 age of eighteen.
- 15 The legislature further finds that any person who is not in
- 16 compliance with the Military Selective Service Act is ineligible

- 1 for federal student financial assistance and employment within
- 2 the executive branch of the federal government.
- 3 The purpose of this Act is to require compliance with the
- 4 Military Selective Service Act to be eligible for enrollment in
- 5 a state-supported post-secondary institution, qualify for state

- 11 (b) The University of Hawaii shall ensure that applicants
  12 and enrollees under its jurisdiction comply with the Military
  13 Selective Service Act for the purposes of this section.
  - § -4 Compliance; state and county employment and service. (a) Notwithstanding any law to the contrary, no male United States citizen and every other male person residing in the United States between the ages of eighteen and twenty-six, who are not in compliance with the Military Selective Service Act, shall be eligible for employment by the State or any political subdivision of the State, or eligible for service for the State or any political subdivision of the State, including

- 1 all offices, self-governing bodies, boards and commissions,
- 2 departments, agencies, institutions, and instrumentalities.
- 3 (b) The State and respective counties shall ensure that
- 4 employees under their jurisdiction comply with the Military
- 5 Selective Service Act for the purposes of this section.
- 6 § -5 Exceptions. A person shall not be denied a right,
- 7 privilege, or benefit under this chapter for noncompliance with
- 8 the Military Selective Service Act if the person is:
- 9 (1) Eighteen years of age or under, or over twenty-six
- 10 years of age;
- 11 (2) In the armed forces of the United States on active
- duty, other than in a reserve or National Guard unit
- or has already served in the armed forces or has a
- 14 condition that would preclude acceptability for
- 15 military service;
- 16 (3) Neither a United States citizen nor a resident
- immigrant;
- 18 (4) A permanent resident of the Trust Territory of the
- 19 Pacific Island or the Northern Mariana Islands; or

1	(5) Is excused from registration for some other reason
2	provided by the Military Selective Service Act and
3	that reason is included in a written statement.
4	§ -6 Severability. If any provision of this chapter, or
5	the application thereof to any person or circumstance is held
6	invalid, the invalidity does not affect other provisions or
7	applications of the chapter which can be given without the
8	invalid provision or application, and to this end the provisions
9	of this chapter are severable."
10	SECTION 3. This Act shall take effect upon its approval.
