A BILL FOR AN ACT

RELATING TO UMBILICAL CORD BLOOD PRE-REGISTRATION FORMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that, according to
- 2 research conducted by a Farrington high school student, the need
- 3 for umbilical cord blood stem cell transplants are growing
- 4 rapidly in Hawaii. Specifically, anyone coming from an ethnic
- 5 minority group, such as those of Asian or Pacific islander
- 6 descent, has a lesser likelihood of finding a match through the
- 7 National Marrow Donor Program than the population-at-large due
- 8 to the lack of donations from the minority group.
- 9 The legislature also finds that many people in Hawaii
- 10 expecting a child are not familiar with the options available to
- 11 them when it comes to their infant's umbilical cord blood.
- 12 Hawaii residents require basic information regarding umbilical
- 13 cord blood, the benefits it presents, and the need for donors,
- 14 especially from an ethnic minority group. The legislature
- 15 further finds that all labor and delivery hospitals in the city
- 16 and county of Honolulu provide registration papers with brief
- 17 information and a signed consent form, disclosing preferred

- 1 action that expectant parents may take in regards to their
- 2 infant's umbilical cord blood.
- 3 Accordingly, the purpose of this Act is to ensure that
- 4 anyone having a child shall be made aware of the options
- 5 available to them in regards to their infant's umbilical cord
- 6 blood following delivery.
- 7 SECTION 2. The Hawaii Revised Statutes is amended by
- 8 adding a new chapter to be appropriately designated and to read
- 9 as follows:
- 10 "CHAPTER
- 11 UMBILICAL CORD BLOOD PRE-REGISTRATION FORM
- 12 § -1 Short title. This chapter shall be known and cited
- 13 as the "Umbilical Cord Blood Pre-Registration Form."
- 14 § -2 Form with three options. As a part of the
- 15 registration process for expectant parents, all labor and
- 16 delivery hospitals in the State shall provide the expectant
- 17 parents with brief information on umbilical cord blood and a
- 18 signed consent form on three options available to them regarding
- 19 umbilical cord blood. The three options are as follows:
