A BILL FOR AN ACT

RELATING TO MEDICAL AMNESTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that drug overdoses have
- 2 overtaken motor vehicle accidents in recent years as the leading
- 3 cause of fatal injuries in Hawaii.
- 4 From 2009 through 2013, seven hundred seventy-three deaths
- 5 from drug overdoses were recorded in Hawaii, including a record-
- 6 high one hundred eighty-three deaths in 2013, according to the
- 7 state Department of Health.
- 8 In the United States, drug overdoses have tripled since
- 9 1990 and are a major cause of preventable death. Often medical
- 10 assistance for a drug overdose is not sought by those in need or
- 11 their companions for fear of being arrested for use, possession
- 12 or other drug-related crimes.
- 13 States recently have enacted overdose immunity laws
- 14 intended to reduce the number of overdose-related deaths by
- 15 encouraging people to seek help. The legislature finds that as
- 16 of November 2014, twenty-three states have passed overdose
- 17 immunity laws, also known as Good Samaritan and medical amnesty



- 1 policies, to encourage people to call 911 when witnessing or
- 2 experiencing an alcohol or drug overdose by providing a limited
- 3 shield from charge and prosecution for possession of a
- 4 controlled substance, drug paraphernalia, and for minors,
- 5 alcohol.
- 6 The legislature finds that in Hawaii about seventy per cent
- 7 of persons who witness a drug overdose do not call 911 for fear
- 8 of arrest or prosecution, according to data reported by the
- 9 Community Health Outreach Work to Prevent HIV/AIDS program.
- 10 The purpose of this Act is to encourage a witness or a
- 11 victim of a drug or alcohol overdose to call 911 or seek other
- 12 emergency medical assistance in order to save the life of an
- 13 overdose victim by establishing a state law protecting the
- 14 witness or victim from charge, prosecution, and civil forfeiture
- 15 based on certain drug and alcohol related offenses. This Act is
- 16 not intended to protect individuals from charge or prosecution
- 17 for drug trafficking.
- 18 SECTION 2. Chapter 329, Hawaii Revised Statutes, is
- 19 amended by adding a new section to be appropriately designated
- 20 and to read as follows:

2	person who, in good faith, seeks medical assistance for someon	<u>e</u>

5	civil forfeiture, or otherwise prosecuted for possession of a

8	based on evidence that was obtained as a result of the person	
9	seeking or receiving medical assistance.	
10	(b) A person who is experiencing a drug or alcohol	
11	overdose or other life threatening medical emergency and, in	
12	good faith, seeks medical assistance for himself or herself or	
13	is the subject of such a good faith request for medical	
14	assistance, shall not be charged, subject to civil forfeiture,	
15	or otherwise prosecuted for possession of a controlled	
16	substance, intoxicating liquor, or drug paraphernalia under the	is
17	chapter, chapter 281, or part IV of chapter 712, based on	
18	evidence that was obtained as a result of the person seeking or	r
19	receiving medical assistance.	
20	(c) This section shall not apply to a prosecution where	
21	the person who sought the medical assistance illegally sold any	У

- 1 drugs or alcohol at issue to the drug or alcohol overdose
- 2 victim.
- 3 (d) As used in this section:
- 4 "Drug or alcohol overdose" means an acute medical condition
- 5 that is the result of the ingestion or use by an individual of
- 6 alcohol, one or more controlled substances, or one or more
- 7 controlled substances in combination with alcohol in quantities
- 8 that are excessive for that individual that may result in death,
- 9 disability, or serious injury. An individual's condition shall
- 10 be deemed to be a "drug or alcohol overdose" if a reasonable
- 11 person would believe the condition to be a drug or alcohol
- 12 overdose that may result in death, disability, or serious
- 13 injury."
- 14 SECTION 3. This Act does not affect rights and duties that
- 15 matured, penalties that were incurred, and proceedings that were
- 16 begun before its effective date.
- 17 SECTION 4. New statutory material is underscored.

1 SECTION 5. This Act shall take effect on July 1, 2015.
