## A BILL FOR AN ACT

RELATING TO THE LICENSURE OF DURABLE MEDICAL EQUIPMENT SUPPLIERS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Medicare beneficiaries in Hawaii are
- 2 experiencing a reduction in access to quality care as a result
- 3 of the change in the way medicare purchases its durable medical
- 4 equipment and prosthetics, orthotics, and supplies through a
- 5 competitive bidding program. The unintended consequences of the
- 6 implementation of this national program in Honolulu have so far
- 7 been disastrous.
- 8 Only thirteen of the ninety-seven vendors selected are
- 9 located within the State. The minimum shipping time is two to
- 10 four days and the typical wait time for physician-ordered
- 11 wheelchairs and hospital beds is four to eight weeks. Out-of-
- 12 state vendors do not have special phone or service hours to
- 13 account for the time difference which means when medicare
- 14 beneficiaries in Hawaii call after 11:00 a.m., the offices are
- 15 closed. Without access to timely, local services, medicare
- 16 beneficiaries in Hawaii have been forced to wait for or forego

- 1 necessary durable medical equipment and devices. This
- 2 restricted access to care has led to reductions in health,
- 3 increases in preventable admissions and readmissions, increases
- 4 in costs to beneficiaries and the medicare system, and reduced
- 5 quality of life for medicare patients.
- 6 The national bidding program has the laudable intention of
- 7 cutting down on fraud and abuse and reducing medicare costs
- 8 nationally. However, a reduction in cost by twelve to fifty-six
- 9 per cent in Hawaii, as envisioned by the program, is
- 10 unsustainable given the higher fixed costs of rent, utilities,
- 11 and shipping that businesses in Hawaii face. Hawaii's fees are
- 12 now on par with those in the Washington, D.C. area, even though
- 13 the cost of living index in Honolulu is 21.4 per cent higher
- 14 than Washington, D.C.
- 15 Medicare costs in Hawaii were already low. A review of
- 16 2011 fee-for-service medicare spending for durable medical
- 17 equipment shows that Hawaii had the lowest per capita durable
- 18 medical equipment cost in the nation. On average, each Hawaii
- 19 beneficiary consumes only \$82.54 in durable medical equipment,
- 20 compared with \$230.16 nationally. Furthermore, the total
- 21 medicare cost for a Hawaii beneficiary, on average, is only

- 1 \$530.98, compared with \$792.99 nationally.
- 2 The office of health care assurance is organized under the
- 3 state department of health under Chapter 321, Hawaii Revised
- 4 Statutes, to perform all state licensing activities for
- 5 healthcare facilities, agencies, and organizations in Hawaii,
- 6 including conducting all on-site state licensing surveys and
- 7 medicare certification surveys on behalf of the United States
- 8 Centers for Medicare and Medicaid Services.
- 9 The purpose of this Act is to provide for licensure and
- 10 oversight by the office of health care assurance of durable
- 11 medical equipment suppliers to provide durable medical equipment
- 12 to medicare beneficiaries in Hawaii. Due to exigent
- 13 circumstances, the legislature finds that this licensure program
- 14 is needed immediately to ensure that Hawaii's patients have
- 15 timely access to the critical, life-sustaining medical supplies
- 16 they need. Therefore, this licensure program shall be exempt
- 17 from the provisions of section 26H-6, Hawaii Revised Statutes.
- 18 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
- 19 amended by adding a new part to be appropriately designated and
- 20 to read as follows:

- 1 "Supplier" means a person or entity that delivers
- 2 disposable medical supplies or durable medical equipment
- 3 products directly to a recipient and that currently bills or
- 4 plans to bill the medicare program for services or products in
- 5 the current calendar year.
- 6 §321- Licensing. (a) All suppliers of durable medical
- 7 equipment shall be licensed pursuant to this part.
- 8 (b) A supplier of durable medical equipment shall be
- 9 licensed if:
- 10 (1) The supplier maintains an appropriate physical
- 11 location within the State;
- 12 (2) The supplier has passed an annual inspection performed
- by the office of health care assurance; and
- 14 (3) The supplier is registered to do business in the
- 15 State.
- 16 (c) The office of health care assurance shall maintain a
- 17 list of suppliers licensed under this part.
- 18 §321- Annual inspection. (a) The office of health care
- 19 assurance shall perform an inspection of all durable medical
- 20 equipment suppliers before granting licensure pursuant to this
- **21** part.

- 1 SECTION 4. There is appropriated out of the office of
- 2 health care assurance special fund established pursuant to
- 3 section 321-1.4, Hawaii Revised Statutes, the sum of \$
- 4 or so much thereof as may be necessary for fiscal year 2015-2016
- 5 and the same sum or so much thereof as may be necessary for
- 6 fiscal year 2016-2017 for expenses incurred by the office of
- 7 health care assurance to establish and administer the durable
- 8 medical equipment supplier licensing and patient protection
- 9 program, including one full-time equivalent (1.0 FTE) position
- 10 to administer the program.
- 11 The sums appropriated shall be expended by the office of
- 12 health care assurance for the purposes of this Act.
- 13 SECTION 5. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 6. This Act shall take effect on July 1, 2050.
