## A BILL FOR AN ACT

RELATING TO HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 709-908, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§709-908 Tobacco products and electronic smoking devices
- 4 [prohibited; minors.]; persons under twenty-one years of age.
- 5 (1) [It] After July 1, 2015, it shall be unlawful to sell
- 6 or furnish a tobacco product in any shape or form [, including
- 7 chewing tobacco and snuff, or an electronic smoking device to a
- 8 [minor under eighteen] person under twenty-one years of age.
- 9 (2) [Signs] After July 1, 2015, signs using the statement,
- 10 "The sale of tobacco products or electronic smoking devices to
- 11 persons under [eighteen] twenty-one is prohibited", shall be
- 12 posted on or near any vending machine in letters at least one-
- 13 half inch high and at or near the point of sale of any other
- 14 location where tobacco products or electronic smoking devices
- 15 are sold in letters at least one-half inch high.
- 16 (3) It shall be unlawful for a [minor under eighteen]
- 17 person under twenty-one years of age to purchase any tobacco

- 13 nor more than \$2,000. Any [minor under eighteen] person under
- 14 twenty-one years of age who violates subsection (3) shall be
- 15 fined \$10 for the first offense. Any subsequent offense shall
- 16 subject the violator to a fine of \$50, no part of which shall be
- 17 suspended, or the person shall be required to perform not less
- 18 than forty-eight hours nor more than seventy-two hours of
- 19 community service during hours when the person is not employed
- 20 and is not attending school.

1	"Electronic smoking device" means any electronic product
2	that can be used to [simulate smoking in the delivery of]
3	aerosolize and deliver nicotine or other substances to the
4	person inhaling from the device, including but not limited to an
5	electronic cigarette, electronic cigar, electronic cigarillo, or
6	electronic pipe, and any cartridge or other component of the
7	device or related product.
8	"Tobacco product" means any product made or derived from
9	tobacco that contains nicotine or other substances and is
10	intended for human consumption or is likely to be consumed,
11	whether smoked, heated, chewed, absorbed, dissolved, inhaled, or
12	ingested by other means. "Tobacco product" includes but is not
13	limited to a cigarette, cigar, pipe tobacco, chewing tobacco,
14	snuff, snus, or an electronic smoking device. "Tobacco product"
15	does not include drugs, devices, or combination products
16	approved for sale by the United States Food and Drug
17	Administration, as those terms are defined in the Federal Food,
18	Drug and Cosmetic Act."
19	SECTION 2. Statutory material to be repealed is bracketed
