BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 324, Hawaii Revised Statutes, is amended by adding a new part to be appropriately designated and 2 to read as follows: 3 MATERNAL MORTALITY REVIEW PANEL 4 §324-A Definitions. - 4 There is established a panel to conduct comprehensive,
- 5 multidisciplinary reviews of maternal deaths in the State to
- 6 identify factors associated with the deaths and make
- 7 recommendations for system changes to improve health care
- 8 services for women in the State. The members of the panel shall
- 9 be appointed by the director, in collaboration with the
- 10 organizations listed below, and shall consist of:
- 11 (1) Three members from the Hawaii section of the American
- 12 Congress of Obstetricians and Gynecologists, including
- at least one generalist and at least one maternal

- 9 (b) The term of each member shall be three years; provided
- 10 that the initial members' terms shall be staggered in a manner
- 11 to be determined by the director. The director shall appoint
- 12 the initial chair of the panel, who shall call the first meeting
- 13 of the panel and serve as chair for six months, after which time
- 14 the panel shall elect its chair. Members of the panel shall
- 15 serve without compensation but shall be reimbursed for actual
- 16 expenses necessary for the performance of their duties.
- 17 (c) The director may delegate to the panel the functions

- (1) Collecting, analyzing, and disseminating maternalmortality review information;

- 6 §324-C Duties of the maternal mortality review panel.
- 7 (a) The panel, in collaboration with the director or the
- 8 director's designee, shall conduct comprehensive,
- 9 multidisciplinary reviews of maternal mortality in Hawaii. The
- 10 panel shall not be subject to part I of chapter 92.
- 11 (b) The panel may invite consultants to attend reviews of
- 12 maternal mortality events. Each consultant shall be subject to
- 13 the same confidentiality provisions as apply to panel members.
- 14 (c) The panel shall be responsible for disseminating the
- 15 panel's recommendations to the members' institution or
- 16 professional organization as applicable. The panel's
- 17 recommendations shall not contain any information that would
- 18 permit identification of a person and shall be disseminated
- 19 through the institution's or organization's quality assurance
- 20 program to protect the confidentiality of all persons involved
- 21 in any maternal mortality event.

- (e) The panel shall not have the power to:
- 11 (1) Call witnesses or take testimony from any individual 12 involved in the investigation of a maternal death; or
 - (2) Enforce any public health standard or criminal law, or otherwise participate in any legal proceeding, except to the extent that a member of the panel is involved in the investigation of a maternal death or resulting prosecution and participates in the legal proceeding in the course of performing the member's duties outside of the panel.

- 2 medical care and state and county agencies shall report all
- 3 maternal mortality events to the director.
- 4 (b) Upon written request of the director, all providers of
- 5 medical care and state and county agencies shall disclose to the
- 6 department, and those individuals appointed by the director to
- 7 the panel, maternal mortality review information regarding the
- 8 circumstances of a maternal death so that the department may
- 9 conduct a multidisciplinary review of maternal mortality
- 10 pursuant to section 321-31 and this part.
- 11 (c) To the extent that this section conflicts with other
- 12 state confidentiality laws, this section shall prevail.
- 13 §324-E Exception. Information regarding an ongoing civil
- 14 or criminal investigation shall be disclosed at the discretion
- 15 of the applicable state, county, or federal law enforcement
- 16 agency.
- 17 §324-F Use of maternal mortality review information and
- 18 records. (a) Except as otherwise provided in this part, all
- 19 maternal mortality review information acquired by the department
- 20 during its review of maternal deaths pursuant to this part,

- 1 shall be confidential and may only be disclosed as necessary to
- 2 carry out the purposes of this part.
- 3 (b) The department shall redact any individually
- 4 identifiable health information prior to sharing it with panel
- 5 members.
- 6 (c) General maternal mortality review information and
- 7 statistical compilations of data that do not contain any
- 8 information that would permit the identification of any person
- 9 shall be public records.
- 10 (d) The panel and every panel member shall maintain the
- 11 confidentiality of the maternal mortality review information and
- 12 all information obtained as part of the panel proceedings.
- 13 Neither the panel nor any panel member shall release or re-
- 14 disclose information obtained as part of the panel proceedings.
- (e) No individual participating in the panel's review of a
- 16 maternal death shall be questioned in any civil or criminal
- 17 proceeding regarding information presented in or opinions formed
- 18 as a result of a panel meeting. Nothing in this subsection
- 19 shall be construed to prevent a person from testifying to
- 20 information obtained independently of the department's request
- 21 for maternal mortality review information or the panel's review

- 1 of the maternal death, or which is public information, or where
- 2 disclosure is required by a court of law.
- 3 (f) Maternal mortality review information held by the
- 4 department as a result of maternal mortality reviews conducted
- 5 under this part is not subject to subpoena, discovery, or
- 6 introduction into evidence in any civil or criminal proceeding,
- 7 except that maternal mortality review information otherwise
- 8 available from other sources is not immune from subpoena,
- 9 discovery, or introduction into evidence through those sources
- 10 solely because they were provided as required by this part.
- 11 (q) The director shall have access to individually
- 12 identifiable health information relating to each maternal
- 13 mortality event on a case-by-case basis where public health is
- 14 at risk.
- 15 (h) The director may retain individually identifiable
- 16 health information regarding facilities where a maternal
- 17 mortality event occurred and geographic information on each
- 18 maternal mortality event solely for the purposes of trending and
- 19 analysis of maternal mortality events over time.
- 20 §324-G Immunity from liability. The panel, the panel
- 21 members, any medical provider, state or county agency, or

- 1 individual participating in, or cooperating in, the review of a
- 2 maternal death pursuant to this part shall not be held civilly
- 3 or criminally liable for providing the information required
- 4 under this part.
- 5 §324-H Rules. The director, with the advice and
- 6 recommendation of a majority of the members of the panel, shall
- 7 adopt rules pursuant to chapter 91 related to the following:
- 8 (1) The system for identifying and reporting maternal
- 9 mortality events to the director;
- 10 (2) The form and manner through which the director and the
- 11 members of the panel may acquire information pursuant
- 12 to this part;
- 13 (3) The protocol to be used in contacting a family member
- of the deceased woman for a discussion of the maternal
- mortality event, including allowing family members to
- delay or refuse such a discussion; and
- 17 (4) The confidentiality provisions of this part."
- 18 SECTION 2. Section 324-1, Hawaii Revised Statutes, is
- 19 amended to read as follows:
- 20 "\$324-1 Sources of information protected. Any person,
- 21 hospital, sanitorium, nursing or rest home, or other similar

- 1 medical facility may provide information, interviews, reports,
- 2 statements, memoranda, or other data or material relating to the
- 3 condition and treatment of any person to the [maternal and
- 4 perinatal mortality study-committee of the Hawaii Medical
- 5 Association, any in-hospital staff committee, or the] department
- 6 of health [-] to be used in the course of any study for the
- 7 purpose of reducing morbidity or mortality.
- 8 No liability of any kind or character for damages or other
- 9 relief shall arise or be enforced against any person or
- 10 organization by reason of having provided the information or
- 11 material, or by reason of having released or published the
- 12 findings, conclusions, and summaries of the research or study
- 13 committees to advance medical research and medical education."
- 14 SECTION 3. Section 324-2, Hawaii Revised Statutes, is
- 15 amended to read as follows:
- 16 "\$324-2 Identification of persons studied; restriction.
- 17 The [maternal and perinatal mortality study committee of the
- 18 Hawaii Medical Association, the department of health, or any in
- 19 hospital staff committee] maternal mortality review panel shall
- 20 use or publish this material only for the purpose of advancing
- 21 medical research, medical education, or education of the public

- 1 in the interest of reducing morbidity or mortality. In all
- 2 events, the identity, or any group of facts which tends to lead
- 3 to the identity, of any person whose condition or treatment has
- 4 been studied shall be confidential and shall not be revealed
- 5 [under any circumstances]."
- 6 SECTION 4. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$10,000 or so much
- 8 thereof as may be necessary for fiscal year 2015-2016 and the
- 9 same sum or so much thereof as may be necessary for fiscal year
- 10 2016-2017 for the implementation and operation of the maternal
- 11 mortality review panel.
- 12 The sums appropriated shall be expended by the department
- 13 of health for the purposes of this Act.
- 14 SECTION 5. In codifying the new sections added by section
- 15 1 of this Act, the revisor of statutes shall substitute
- 16 appropriate section numbers for the letters used in designating
- 17 the new sections in this Act.
- 18 SECTION 6. Statutory material to be repealed is bracketed
- 19 and stricken. New statutory material is underscored.

SECTION 7. This Act shall take effect on July 1, 2015.
