

### A BILL FOR AN ACT

RELATING TO CLIMATE CHANGE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is
- 2 overwhelming evidence that human activities are altering the
- 3 earth's climate and that climate change will have significant
- 4 local and global health impacts. Climate change and related
- 5 health impacts transcend national borders and it is probable
- 6 that climate change health impacts in other countries will
- 7 affect the health of people throughout the United States,
- 8 including Hawaii. Famine, drought, extreme weather events, and
- 9 regional conflicts, all likely consequences of climate change,
- 10 increase the incidence of disease and contribute to various
- 11 adverse health impacts, making it imperative to address climate
- 12 change at the national and local level. Climate change will
- 13 affect the health of people globally and in Hawai'i and it is
- 14 imperative to mitigate the health-related impacts.
- The legislature further finds that as a result of Hawai'i's
- 16 unique geographic location and isolation, Hawai'i is particularly
- 17 vulnerable to the impacts of climate change, including

- 1 contamination or decrease in the water, food, and energy supply.
- 2 Various potential health impacts of climate change include
- 3 respiratory allergies, airway diseases, food-borne diseases,
- 4 biotoxin exposure, heat-related illnesses, cancer,
- 5 cardiovascular diseases, vector-borne diseases, and waterborne
- 6 diseases. Yet, Hawai'i's health community lacks the knowledge
- 7 and training required to prepare for and respond to various
- 8 potential health impacts of climate change.
- 9 The purpose of this Act is to create a climate change and
- 10 health working group to examine various potential health impacts
- 11 of climate change and assist Hawai'i's health professionals in
- 12 effectively and efficiently preparing for and responding to the
- 13 various potential health impacts.
- 14 SECTION 2. Section 225P-3, Hawaii Revised Statutes, is
- 15 amended by amending subsection (e) to read as follows:
- "[+](e)[+] In developing the report, the committee shall:
- 17 (1) Solicit public views and concerns; [and]
- 18 (2) Coordinate with the various county, state, and federal
- 19 agencies involved in ongoing climate change adaptation
- 20 planning initiatives [-]; and

17		disease surveillance and monitoring systems to respond
18		to various potential health impacts of climate change,
19		including but not limited to water and food safety and
20	ï	security, vector-borne infectious disease, respiratory

1		and cardiovascular health, mental and behavioral
2		health, and community or population-specific health;
3	(3)	Create evidence-based tools to predict and monitor the
4		public health impacts of climate change in the State;
5	(4)	Identify and prioritize communities and populations
6		that may be vulnerable to various potential health
7		impacts of climate change and develop a strategy to
8		inform and protect these communities and populations;
9	(5)	Develop and recommend programs for public health care
10		professionals and the public to promote climate-change
11		preparedness and response strategies related to public
12		health;
13	(6)	Develop and recommend ways to expand and train the
14		public health workforce to strengthen the workforce's
15		ability to respond to and prepare for the various
16		potential health impacts of climate change; and
17	(7)	Develop and recommend ways to advance, implement, and
18		support state and local preparedness, including
19		communication and response plans.
20	(d)	The working group shall submit a report of its
21	findings	and recommendations, including any proposed

- legislation, to the interagency climate adaption committee and 1
- 2 provide the interagency climate adaption committee with ample
- 3 time to incorporate the working group's applicable findings and
- 4 recommendations into the interagency climate adaption
- 5 committee's report due to be published no later than
- December 31, 2017. The working group shall be dissolved on 6
- 7 June 30, 2018.
- The members of the working group shall serve without 8
- compensation but shall be reimbursed for expenses, including 9
- travel expenses, necessary for the performance of their duties. 10
- 11 SECTION 4. Statutory material to be repealed is bracketed
- and stricken. New statutory material is underscored. 12
- SECTION 5. This Act shall take effect upon its approval. 13
