A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that sexuality health
- 2 education promotes healthy attitudes on adolescent growth and
- 3 development, body image, gender and sexuality, dating,
- 4 relationships, and family. The legislature also finds that
- 5 sexuality health education should positively affect adolescent
- 6 behavior and provide teens with the information, skills, and
- 7 support needed to develop positive values, make healthy
- 8 decisions, and respect the important role that sexuality plays
- 9 throughout a person's life.
- The legislature further finds that, in the past three
- 11 years, several states, including Hawaii, have enacted laws that
- 12 require school districts that teach sexuality health education
- 13 to include age-appropriate and medically accurate health
- 14 education. The legislature also finds, however, that the
- 15 effectiveness of sexuality health education in Hawaii's schools
- 16 could be bolstered by providing clearer guidance on a
- 17 comprehensive approach to sexuality health education, greater



- flexibility in the implementation of the curricula, and greater 1 public access to the curricula. 2 The purpose of this Act is to: 3 Add specific requirements to Hawaii's existing 4 (1) sexuality health education law; 5
- Require the board of education and department of 6 (2) education to collaborate to develop, maintain, and 7 make available to the public a list of sexuality 8 health education curricula; and 9
- (3) Allow parents to request that their children not 10 receive the sexuality health education provided 11 pursuant to Hawaii's sexuality health education law. 12
- SECTION 2. Section 321-11.1, Hawaii Revised Statutes, is 13 amended to read as follows:

"Age appropriate" means suitable to a particular age or age 1 group based on developing cognitive, emotional, and behavioral 2 capacity typical for that age or age group. 3 "Factual information" means medical, psychiatric, 4 psychological, empirical, or statistical information that is 5 verified or supported by research conducted by recognized 6 medical, psychiatric, psychological, and public health 7 professionals or organizations. 8 "Medically accurate" means verified or supported by 9 research conducted in compliance with accepted scientific 10 methods and recognized as accurate and objective by professional 11 organizations and agencies with expertise in the relevant field, 12 such as the federal Centers for Disease Control and Prevention, 13 the American Public Health Association, the American Academy of 14 Pediatrics, and the American College of Obstetricians and 15 16 Gynecologists. "Sexuality health education" means education in any medium 17 regarding human development and sexuality, including education 18

on pregnancy, family planning, and sexually transmitted

diseases."
