

A BILL FOR AN ACT

RELATING TO CAMPAIGN FINANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended
- 2 by adding a new section to subpart E of part XIII to be
- 3 appropriately designated and to read as follows:
- 4 "S11- Corporations; contributions and expenditures;
- 5 determination of shareholder will required. (a) No corporation
- 6 shall make any contribution or expenditure to or on behalf of
- 7 any candidate, candidate committee, or noncandidate committee,
- 8 or make any independent expenditure, except in accordance with
- 9 the will of the majority of all shareholders of the corporation,
- 10 as determined through the procedures required under subsection
- 11 (b).
- 12 (b) A corporation shall include procedures in its bylaws
- 13 for assessing the will of the majority of all shareholders of
- 14 the corporation regarding any proposal by the corporation to
- 15 make a contribution, expenditure, or independent expenditure.
- (c) The distribution of a news story, commentary,
- 17 editorial, book, or documentary in the ordinary course of
