A BILL FOR AN ACT

RELATING TO INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 286-26, Hawaii Revised Statutes, is
 amended by amending subsection (i) to read as follows:
 "(i) As part of the inspection required by this section

3 "(i) As part of the inspection required by this section,
4 the owner of the vehicle to be inspected shall produce and
5 display the motor vehicle insurance identification card for the
6 inspected motor vehicle required by section 431:10C-107 or the
7 proof of insurance card required by section 431:10G-106.

8 The owner of the vehicle may display the motor vehicle 9 insurance identification card or the proof of insurance card in 10 electronic format on a mobile electronic device, as defined in 11 section 291C-137.

12 If no card is displayed, then the sticker authorized by the 13 director shall not be affixed to the vehicle and the certificate 14 of inspection shall not be issued."

15 SECTION 2. Section 286-108, Hawaii Revised Statutes, is 16 amended by amending subsection (d) to read as follows:

1 "(d) As part of the examination required by this section, 2 the applicant for a driver's license shall produce and display a 3 valid motor vehicle or liability insurance identification card 4 for the motor vehicle required by sections 431:10C-107 and 5 431:10G-106, when the applicant demonstrates the ability to 6 operate a motor vehicle to the satisfaction of the examiner of 7 drivers. 8 The applicant may display the motor vehicle or liability 9 insurance identification card in electronic format on a mobile 10 electronic device, as defined in section 291C-137. 11 If no valid motor vehicle or liability insurance 12 identification card is displayed, the examiner of drivers shall 13 not issue a driver's license to the applicant." 14 SECTION 3. Section 286-116, Hawaii Revised Statutes, is 15 amended by amending subsection (a) to read as follows: "(a) Every licensee shall have a valid driver's license in 16 17 the licensee's immediate possession at all times, and a valid motor vehicle or liability insurance identification card 18 19 applicable to the motor vehicle operated as required under 20 section 431:10C-107 and section 431:10G-106, when operating a 21 motor vehicle, and shall display the same upon demand of a

1 police officer. Every police officer or law enforcement officer 2 when stopping a vehicle or inspecting a vehicle for any reason 3 shall demand that the driver or owner display the driver's or 4 owner's driver's license and insurance identification card. 5 Upon demand, the driver or owner may display the driver's 6 or owner's insurance identification card in electronic format on 7 a mobile electronic device, as defined in section 291C-137. For 8 the purposes of this section, when a person uses a mobile 9 electronic device to display an insurance identification card to 10 a police officer or law enforcement officer, the officer may 11 only view the insurance identification card and is otherwise 12 prohibited from viewing any other content on the mobile 13 electronic device. Whenever a person presents a mobile 14 electronic device pursuant to this section, that person assumes 15 all liability for any damage to the mobile electronic device. 16 No person charged with violating this section shall be 17 convicted if the person produces in court, or proves from the proper official or other records that the person was the holder 18 19 of a driver's license or a motor vehicle or liability insurance 20 identification card and policy conforming to article 10C and article 10G of chapter 431 or a certificate of self-insurance

1 issued by the insurance commissioner pursuant to section 2 431:10C-107 and section 431:10G-103, theretofore issued to the 3 person and valid at the time of the person's arrest." 4 SECTION 4. Section 431:10C-107, Hawaii Revised Statutes, 5 is amended by amending subsections (b) and (c) to read as 6 follows: 7 "(b) The identification card shall be in the insured motor 8 vehicle or carried by the operator of the insured motor vehicle 9 at all times and shall be exhibited to a law enforcement officer 10 upon demand. .11 (C) The identification card may be issued in either paper 12 or electronic format; provided that the identification card 13 shall be resistant to forgery by whatever means appropriate. 14 Acceptable electronic formats shall include the display of 15 electronic images on a mobile electronic device, as defined in 16 section 291C-137. The commissioner shall approve the 17 construction, form, and design of the identification card to ensure that the card is forgery resistant." 18 19 SECTION 5. Section 431:10G-106, Hawaii Revised Statutes, 20 is amended to read as follows:

1 "§431:10G-106 Verification of insurance. Every insurer 2 shall issue to each of its insureds a proof of insurance card 3 for each motorcycle or motor scooter for which a liability 4 policy under this article is written. The proof of insurance 5 card may be issued in either paper or electronic format. 6 Acceptable electronic formats shall include the display of 7 electronic images on a mobile electronic device, as defined in 8 section 291C-137. The proof of insurance card shall show the 9 following: 10 (1) Name, make, year, and factory or serial number of the 11 motorcycle or motor scooter; provided that insurers of 12 five or more motorcycles or motor scooters that are 13 under common registered ownership and used in the 14 regular course of business shall not be required to 15 indicate the name, make, year, and the factory or 16 serial number of each motorcycle or motor scooter; 17 (2)Policy number; 18 (3) Names of the insured and the insurer; and 19 Effective dates of coverage including the expiration (4)20 date.

The proof of insurance card shall be carried on the person
 operating the insured motorcycle or motor scooter at all times
 and shall be exhibited to a law enforcement officer upon
 demand."


5 SECTION 6. This Act does not affect rights and duties that 6 matured, penalties that were incurred, and proceedings that were 7 begun before its effective date.


8 SECTION 7. Statutory material to be repealed is bracketed9 and stricken. New statutory material is underscored.
