A BILL FOR AN ACT

RELATING TO CONTRACTORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 104-22, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§104-22 Investigation; penalties. (a) The department
- 4 may conduct investigations to determine compliance with this
- 5 chapter. The department may enter the job site, examine records
- 6 of any contractor, either during or after the performance of any
- 7 contract, or subpoena the records. The department may also
- 8 interview employees during working hours on the job.
- 9 (b) If any contractor interferes with or delays any
- 10 investigation by the department, the governmental contracting
- 11 agency, on receipt of written notice from the director of the
- 12 interference or delay, shall withhold from the contractor all
- 13 further payments until the director has notified the
- 14 governmental contracting agency in writing that the interference
- 15 or delay has ceased. Interference or delay includes failure to
- 16 provide requested records under section 104-3; failure to allow
- 17 employees to be interviewed during working hours on the job; and

- 1 falsification of records required under this chapter. The
- 2 department shall assess a penalty of \$10,000 per project for
- 3 interference or delay. For each day thereafter that the
- 4 employer fails to cooperate, the director shall assess a penalty
- 5 of \$1,000 per project.
- 6 (c) The department may provide training for and deputize
- 7 no fewer than persons to serve as volunteer investigators
- 8 to conduct investigations pursuant to this section. Any
- 9 volunteer investigator deputized by the department who, in good
- 10 faith, provides services pursuant to this chapter shall not be
- 11 liable in any civil action for damages as a result of any acts
- 12 or omissions in conducting or participating in an investigation;
- 13 provided that the skill and care given is that ordinarily
- 14 required and exercised by an investigator.
- 15 (d) The department shall adopt rules in accordance with
- 16 chapter 91 to implement this section."
- 17 SECTION 2. The department of labor and industrial
- 18 relations shall submit reports of its findings and
- 19 recommendations, including any proposed legislation, to the
- 20 legislature not less than twenty days prior to the convening of
- 21 the regular sessions of 2016, 2017, and 2018, on the

- 1 effectiveness of the training and deputizing of the volunteer

- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so much
- 5 thereof as may be necessary for fiscal year 2015-2016 and the
- 6 same sum or so much thereof as may be necessary for fiscal year
- 7 2016-2017 for the training and deputizing of volunteer
- 8 investigators investigating in public work projects.
- 9 The sums appropriated shall be expended by the department
- 10 of labor and industrial relations for the purposes of this Act.
- 11 SECTION 4. New statutory material is underscored.
- 12 SECTION 5. This Act shall take effect on July 1, 2112.
