A BILL FOR AN ACT

RELATING TO HUMAN SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that current state
- 2 welfare policy often penalizes welfare recipients who seek job
- 3 promotions or higher paying career opportunities. Earning more
- 4 from working often causes welfare recipients to lose their
- 5 beneficiary status, thus perpetuating financial hardship. The
- 6 legislature further finds that there is a need to revise the
- 7 welfare payment system to allow recipients to advance in their
- 8 careers without necessarily losing their beneficiary status.
- 9 The purpose of this Act is to request the financial
- 10 assistance advisory council to assist the department of human
- 11 services in proposing recommendations to restructure the welfare
- 12 payment system and to report any findings to the legislature.
- SECTION 2. (a) Beginning no later than January 1, 2016,
- 14 the financial assistance advisory council, established pursuant
- 15 to section 346-14.5, Hawaii Revised Statutes, shall assist the

- 3 (1) Examine the current welfare payment structure;
- 4 (2) Examine possible ways to revise the welfare payment

- 8 beneficiary status;
- 9 (3) Create a sliding-scale payment system to incrementally reduce welfare payments to recipients as they advance
- in their careers or obtain higher-paying jobs; and
- 12 (4) Explore other possible methods to incentivize welfare
- 13 recipients to seek financial self-sufficiency.
- 14 (b) The financial assistance advisory council shall report
- 15 to the legislature no later than twenty days prior to the
- 16 convening of the 2016 regular session on its findings and
- 17 recommendations, including any recommendations for an
- 18 implementation plan or legislation.
- 19 SECTION 3. This Act shall take effect on July 1, 2015.
