RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 286, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	§286- Autocycles. (a) Every autocycle operated in
5	this State, shall first be registered as a motor vehicle as
6	provided in section 286-41.
7	(b) No person shall operate an autocycle on a public
8	street, road, or highway in this State unless the person
9	possesses a valid driver's license and the autocycle has been
10	duly registered."
11	SECTION 2. Section 286-2, Hawaii Revised Statutes, is
12	amended by adding a new definition to be appropriately inserted
13	and to read as follows:
14	""Autocycle" means a three-wheeled motor vehicle powered by
15	a gasoline engine on which the driver and all passengers ride in
16	a completely enclosed, tandem seating area, that is equipped
17	with a roll cage, safety belts for all occupants, airbag

1	protection, and anti-lock brakes and that is designed to be
2	controlled with a steering wheel and pedals."
3	SECTION 3. Section 286-102, Hawaii Revised Statutes, is
4	amended by amending subsection (b) to read as follows:
5	"(b) A person operating the following category or
6	combination of categories of motor vehicles shall be examined as
7	provided in section 286-108 and duly licensed by the examiner of
8	drivers:
9	(1) Mopeds;
10	(2) Motorcycles and motor scooters;
11	(3) [Passenger] <u>Autocycles, passenger</u> cars of any gross
12	vehicle weight rating, buses designed to transport
13	fifteen or fewer occupants, and trucks and vans having
14	a gross vehicle weight rating of eighteen thousand
15	pounds or less; and
16	(4) All of the motor vehicles in category (3) and any
17	vehicle that is not a commercial motor vehicle.
18	A school bus or van operator shall be properly licensed to
19	operate the category of vehicles that the operator operates as a
20	school bus or van and shall comply with the standards of the

1 department of transportation as provided by rules adopted

2 pursuant to section 286-181."

3 SECTION 4. Statutory material to be repealed is bracketed4 and stricken. New statutory material is underscored.

5 SECTION 5. This Act shall take effect upon its approval.
