A BILL FOR AN ACT

RELATING TO ANIMAL CRUELTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that despite the				
2	enactment of several animal cruelty offenses, local humane				
3	societies, law enforcement agencies, and animal protection				
4	groups continue to receive reports of dogs and cats being sold,				
5	trafficked, or slaughtered for human consumption. Some of these				
6	cases involve dogs and cats that were stolen or lost or acquired				
7	via online advertisements for dogs or cats "free to good home".				
8	The purpose of this Act is to:				
9	(1) Prohibit the slaughtering or trafficking of dogs or				
10	cats for human consumption; and				
11	(2) Amend the relevant portion of the definition of "pet				
12	animal" as used in chapter 711, Hawaii Revised				
13	Statutes, to mean any dog or cat, regardless of				
14	whether the dog or cat was bred for consumption.				
15	SECTION 2. Chapter 711, Hawaii Revised Statutes, is				
16	amended by adding a new section to be appropriately designated				
17	and to read as follows:

5	SECTION 3. Section 711-1100, Hawaii Revised Statutes, is					
6	amended by amending the definition of "pet animal" to read as					
7	follows:					
8	""Pet animal" means [a]:					
9	(a) Any dog[-] or cat[-]; or					
10	(b) A domesticated rabbit, guinea pig, domesticated pig,					
11	or caged birds (passeriformes, piciformes, and					
12	psittaciformes only) so long as not bred for					
13	consumption."					
14	SECTION 4. This Act does not affect rights and duties that					
15	matured, penalties that were incurred, and proceedings that were					
16	begun before its effective date.					
17	SECTION 5. Statutory material to be repealed is bracketed					
18	and stricken. New statutory material is underscored.					
19	SECTION 6. This Act shall take effect upon its approval.
