

### A BILL FOR AN ACT

RELATING TO NON-GENERAL FUNDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART
2	SECTION 1. The purpose of this Act is to implement
3	recommendations of the auditor in report no. 14-13, entitled
4	review of special funds, revolving funds, trust funds and trust
5	accounts of the departments of the attorney general and
6	business, economic development and tourism.
7	PART II
8	SECTION 2. The purpose of this part is to reclassify the
9	antitrust trust fund as a special fund.
10	The legislature finds that while the fund continues to
11	serve the purpose for which it was created, it operates more
12	like a special fund and should be reclassified as a special
13	fund.
14	SECTION 3. Section 28-13, Hawaii Revised Statutes, is
15	amended by amending the title and subsections (a) to (c) to read
16	as follows:

1	"[+] §28-13[+] Antitrust [trust] special fund. (a) There
2	is established in the state treasury the antitrust [trust]
3.	special fund, into which shall be deposited:
4	(1) Ten per cent of any antitrust judgment or settlement
5	received by the State except where the deposit is
6	inconsistent with the court order or settlement
7	agreement relating to the amount; and
8	(2) Appropriations made by the legislature.
9	(b) The antitrust [trust] special fund shall be
10	administered by the department of the attorney general and shall
11	be used for expenditures relating to the enforcement of
12	antitrust laws, including [but not limited to] expenditures for
13	training, equipment purchases, educational resources, and
14	facilitating participation in antitrust lawsuits and
15	investigations initiated by other states.
16	(c) All unencumbered and unexpended moneys in excess of
17	\$250,000 remaining on balance in the antitrust [trust] special
18	fund at the close of June 30 of each year shall lapse to the
19	credit of the general fund."

# H.B. NO. 80

1	SECTION 4. The purpose of this part is to abolish the
2	Hawaii criminal justice commission trust account.
3	The legislature finds that the trust account does not serve
4	the purpose for which it was created and should be closed.
5	SECTION 5. The Hawaii criminal justice commission trust
6	account established in 1985 and administered by the department
7	of the attorney general is abolished and any remaining
8	unencumbered balances shall be transferred to the general fund.
9	PART IV
10	SECTION 6. The balance in the fund renamed and
11	reclassified pursuant to section 3 of this Act shall remain in
12	the fund as if no renaming and reclassification had occurred.
13	PART V
14	SECTION 7. Statutory material to be repealed is bracketed
15	and stricken. New statutory material is underscored.
16	SECTION 8. This Act shall take effect on July 1, 2015.
