### A BILL FOR AN ACT

MAKING AN APPROPRIATION TO THE HAWAII ASSOCIATION OF CONSERVATION DISTRICTS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Hawaii
- 2 association of conservation districts, through coordination,
- 3 facilitation, and partnerships assists government agencies in
- 4 identifying and implementing culturally-sensitive projects and
- 5 practices to ensure the protection of Hawaii's environment. The
- 6 Hawaii association of conservation districts comprises sixteen
- 7 districts representing every community on all major islands of
- 8 Hawaii. Chapter 180, Hawaii Revised Statutes, authorizes the
- 9 soil and water conservation districts to operate as government
- 10 subdivisions to educate the public and construct and maintain
- 11 conservation projects and programs in Hawaii. Each of the
- 12 sixteen districts is governed by five volunteer directors and is
- 13 supported by staff. The department of land and natural
- 14 resources provides administration and maintains oversight
- 15 authority of the soil and water conservation districts.

1	The soil and water conservation districts have worked to
2	improve Hawaii's environment and economy through major projects
3	over the past sixty years. While these projects do not occur in
4	all districts every year, collaborative efforts with partners
5	and government agencies have brought millions of dollars to
6	Hawaii to improve farm practices, reduce erosion, improve ocean
7	and drinking water quality, fight invasive species, improve
8	public safety, protect property, conserve water, and strengthen
9	the economy. The soil and water conservation districts also
10	provide educational and community support for conservation
11	awareness. The districts participate in resource conservation
12	and development projects and statewide high school programs.
13	The districts also introduce conservation principles in
14	elementary schools.
15	In addition, the soil and water conservation districts
16	assist with reviewing each county's grading permits and
17	conservation plans. County grading permit reviews and
18	conservation plans are critical to preserve the environment,
19	stimulate the economy, and maintain individual livelihoods. The
20	demand and accompanying workload for this service have increased
21	dramatically with population growth and land use changes. The

- 1 districts receive hundreds of requests for conservation plans
- 2 and county grading permit reviews each year. As a result,
- 3 districts are currently struggling to keep pace with the demand.
- 4 The state department of health recently notified the Hawaii
- 5 association of conservation districts that the current oil
- 6 pollution funding would end on December 31, 2013, and a new
- 7 potential, but not guaranteed, funding mechanism will utilize
- 8 federal "Clean Water Act" funds (Federal Water Pollution Control
- 9 Act, title 33 United States Code section 1329) for the program,
- 10 thus limiting services to those entities within priority
- 11 watershed areas that have approved watershed plans. This is
- 12 problematic as many of Hawaii's farming areas are not within
- 13 priority watersheds. On Maui, for example, the breadbasket of
- 14 Omaopio and Pulehu, including the county agricultural park and
- 15 the expanding Haiku flower production district, exists outside
- 16 of these areas. Therefore, a priority of the relevant soil and
- 17 water conservation district is the identification of solutions
- 18 that provide continued delivery of services to all farmers and
- 19 ranchers.
- 20 The legislature also finds that the current funding
- 21 mechanism proposed by the department of health will result in

- 1 delays within the Maui county department of public works for
- 2 farm-level grubbing and grading permits. County funding
- 3 currently addresses review and recommendations associated with
- 4 non-farm plans. The existing department of health-funded soil
- 5 and water conservation district program covered all conservation
- 6 plan requirements on agricultural lands. However, as proposed,
- 7 the new department of health process will exclude many farms,
- 8 causing them to fall under the county grubbing and grading
- 9 permit process. Even as these farmers are referred to the soil
- 10 and water conservation district by the county of Maui department
- 11 of public works, there will be no one to assist them.
- 12 The county of Maui department of planning often requests
- 13 landowners to obtain farm plans. These plans are prepared by
- 14 the conservation specialist. This service would no longer be
- 15 available. Additionally, the department of health has requested
- 16 that the conservation specialist take a more active role in the
- 17 enforcement of conservation plan provisions. The soil and water
- 18 conservation districts have not assumed this role, because
- 19 advocacy and enforcement by the same entity may cause conflicts,
- 20 and more importantly, result in a reluctance by farmers and
- 21 ranchers to participate in conservation programs.

- 1 Finally, the legislature finds that agriculture in Hawaii
- 2 is rapidly evolving. Many new farmers are immigrants who
- 3 frequently are unfamiliar with United States laws. Educational
- 4 assistance, including education about conservation measures,
- 5 will be important to ensure that these new farmers and ranchers
- 6 adopt good environmental stewardship as a core value while
- 7 seeking economic viability.
- 8 The purpose of this Act is to appropriate moneys to the
- 9 Hawaii association of conservation districts to assist with its
- 10 staffing and operating costs while providing time for the
- 11 districts to develop sustainable funding mechanisms.
- 12 SECTION 2. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$350,000 or so much
- 14 thereof as may be necessary for fiscal year 2015-2016 and the
- 15 same sum or so much thereof as may be necessary for fiscal year
- 16 2016-2017 for staffing and operating costs of the Hawaii
- 17 association of conservation districts.
- The sums appropriated shall be expended by the department
- 19 of land and natural resources for the purposes of this Act.
