A BILL FOR AN ACT

RELATING TO THE OFFICE OF LANGUAGE ACCESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the office of
- 2 language access was established by Act 290, Session Laws of
- 3 Hawaii 2006, and amended by Act 201, Session Laws of Hawaii
- 4 2012, to provide oversight, central coordination, and technical
- 5 assistance to twenty-six state agencies and approximately one
- 6 hundred fifty state-funded agencies in implementing the
- 7 requirements of Hawaii's language access law.
- 8 The office of language access has a statutory mandate to
- 9 ensure that state and state-funded agencies are in compliance
- 10 with Hawaii's language access law. The office of language
- 11 access provides technical assistance to agencies in the form of
- 12 needs assessments, assistance with language access plans,
- 13 training of agency staff, work with interpreters and
- 14 translators, and data collection and reporting. The office of
- 15 language access also conducts periodic compliance monitoring,
- 16 provides complaint resolution, and reports annually to the
- 17 governor and legislature. The office's staff was cut to a

- 1 single position in 2009 due to the State's reduction in force.
- 2 Although two of the six positions were restored in 2013,
- 3 critical staff positions remain unfilled.
- 4 The legislature further finds that Act 217, Session Laws of
- 5 Hawaii 2013, created the language access resource center within
- 6 the office of language access. The delay and timing of the
- 7 executive branch's release of funds to staff the language access
- 8 resource center made it impossible to fill the positions
- 9 established by Act 217.
- 10 The objectives of the language access resource center are
- 11 laudable, but require a tremendous amount of planning,
- 12 coordination, and management. The existing office of language
- 13 access staff expended great efforts and manpower to get the
- 14 language access resource center off the ground work which was
- 15 envisioned to fall on the desks of the new language access
- 16 resource center staff, who have yet to be hired.
- 17 As a result, the office of language access has not been
- 18 able to fully perform its original statutorily-mandated
- 19 compliance and technical assistance functions. Accordingly,
- 20 many state agencies have been unable to implement important
- 21 aspects of their language access plans due to lack of oversight

- 1 and technical assistance and many limited English proficient
- 2 individuals in Hawaii continue to lack meaningful access to
- 3 government services, programs, and activities.
- 4 The purpose of this Act is to establish three positions
- 5 within the office of language access, as originally envisioned
- 6 in the office's implementing legislation, to assist state
- 7 agencies and state-funded agencies in implementing the
- 8 requirements of Hawaii's language access law.
- 9 SECTION 2. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$200,000 or so much
- 11 thereof as may be necessary for fiscal year 2015-2016 and the
- 12 same sum or so much thereof as may be necessary for fiscal year
- 13 2016-2017 to establish three full-time equivalent (3.0 FTE)
- 14 positions comprised of two program specialists and one office
- 15 assistant within the office of language access to assist state
- 16 agencies and state-funded agencies in implementing the
- 17 requirements of Hawaii's language access law.
- 18 The sums appropriated shall be expended by the department
- 19 of health for the purposes of this Act.

1 SECTION 3. This Act shall take effect on July 1, 2015.
