

### A BILL FOR AN ACT

RELATING TO HAWAII HEALTH SYSTEMS CORPORATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State faces a
- 2 severe shortage of healthcare providers. This shortage is
- 3 particularly acute in the field of primary care, in which most
- 4 healthcare cost savings result from prevention and early
- 5 intervention.
- 6 The legislature further finds that the Hawaii health
- 7 systems corporation primary care training program is an
- 8 effective way to reduce the impact of the shortage of primary
- 9 care providers and improve access to healthcare throughout the
- 10 State. Administered by Hilo medical center in coordination with
- 11 the Hawaii health systems corporation regions, this
- 12 interdisciplinary program includes: the Hawaii island family
- 13 medicine residency program; training for advanced practice
- 14 nurses from the school of nursing and dental hygiene at the
- 15 University of Hawaii at Manoa and the school of nursing at the
- 16 University of Hawaii at Hilo; clinical pharmacists from the
- 17 University of Hawaii at Hilo's college of pharmacy; and post-

- 1 doctoral fellows from I Ola Lahui, an organization that trains
- 2 psychologists to meet the needs of residents of rural areas.
- 3 The success of this program, which will be expanded to
- 4 neighbor island health facilities, will generate
- 5 interdisciplinary teams capable of caring for four times as many
- 6 patients as independent practicing physicians. Hawaii will
- 7 benefit greatly as the Hawaii health systems corporation
- 8 regions' program will eliminate the need to train or attract
- 9 unattainably high numbers of physicians.
- 10 The legislature also finds that the average incremental
- 11 cost of each resident in the program is \$150,000, and that four
- 12 new residents will join the training program in July 2015.
- 13 Additionally, the legislature finds that the increased funding
- 14 for the program provided by this Act over previous
- 15 appropriations and funding requests will cover costs related to
- 16 the new residents and ultimately financially stabilize the
- 17 program.
- 18 The purpose of this Act is to address the shortage of
- 19 primary care providers in the State by appropriating funds for
- 20 the interdisciplinary Hawaii health systems corporation primary
- 21 care training program at Hilo medical center.

- 1 SECTION 2. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$3,600,000 or so much
- 3 thereof as may be necessary for fiscal year 2015-2016 for the
- 4 interdisciplinary Hawaii health systems corporation primary care
- 5 training program at Hilo medical center.
- 6 The sum appropriated shall be expended by the Hawaii health
- 7 systems corporation for the purposes of this Act.
- 8 SECTION 3. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$3,700,000 or so much
- 10 thereof as may be necessary for fiscal year 2016-2017 for the
- 11 interdisciplinary Hawaii health systems corporation primary care
- 12 training program at Hilo medical center.
- 13 The sum appropriated shall be expended by the Hawaii health
- 14 systems corporation for the purposes of this Act.
- 15 SECTION 4. This Act shall take effect on July 1, 2015.
