### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

10	(3)	Community care foster family homes;

14	(6)	Long-term care facilities as defined in section
15		349-21(f); and
16	(7)	Special treatment facilities as defined in section

1 (b) Each inspection report shall be posted on the 2 department of health's website within five working days of the 3 conclusion of each inspection and shall include the following 4 information: 5 (1)The date of the inspection; 6 (2)A description of violations of relevant state laws or 7 rules, if applicable; Plans of correction and the status of corrective 8 (3) 9 actions in response to any violations, if applicable; 10 A list and description of all corrective actions taken (4) 11 by the facility, if applicable, to be submitted by the 12 facility and added to the report at a later time, as 13 determined by the department; and 14 (5) Other information regarding the quality and conditions 15 of the facility the department of health deems 16 appropriate. 17 Each inspection report posted on the department of (C) health's website that reports a violation committed by a state-18 19 licensed care facility as described in subsection (a) shall be 20 removed from the website after three years from the date the 21 report was posted.

12	information to facilitate the placement of individuals in the		
13	facilities, and the posting of vacancy information on the

15	(b) The department of health shall submit a report to the		
16	legislature no later than twenty days before the convening of		
17	the regular session of 2016 on the implementation and		
18	maintenance of a forum on its website and posting of vacancy		
19	information on the website, as specified in subsection (a).		
20	SECTION 3. There is appropriated out of the general

Statutory material to be repealed is bracketed 6 and stricken. New statutory material is underscored. 7 SECTION 5. This Act shall take effect on July 1, 2050. 8
