A BILL FOR AN ACT

RELATING TO THE HAWAIIAN LANGUAGE IMMERSION PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The Hawaiian language, the native language of 2 the Native Hawaiian people, was once a thriving language used by 3 Native Hawaiians and foreigners alike. However, by the late 4 twentieth century, the Hawaiian language was pushed to the brink 5 of extinction due to a number of factors, including an 1896 law 6 that functioned to ban the speaking of the Hawaiian language in 7 Hawaii schools. Fortunately, the Hawaiian language was saved by 8 several historic initiatives, including the department of 9 education's Hawaiian language immersion program, which was 10 launched in the 1980s. The Hawaiian language immersion program, 11 ka papahana kaiapuni, is offered at twenty public schools and 12 educates more than two thousand students in kindergarten through 13 the twelfth grade. 14

Federal accountability assessment requirements present a challenge for ka papahana kaiapuni. Because English is not formally introduced in ka papahana kaiapuni classrooms until the fifth grade, third and fourth grade kaiapuni students have been offered assessments in the Hawaiian language in order to comply HB874 SD2 LRB 15-2510.doc

- 1 with federal accountability assessment requirements. Beginning
- 2 in the 2005-2006 school year and through the 2010-2011 school
- 3 years, these students were offered the Hawaiian aligned
- 4 portfolio assessment, which was developed in the Hawaiian
- 5 language, specifically for ka papahana kaiapuni. During school
- 6 years 2011-2012 through 2013-2014, English-to-Hawaiian
- 7 translations of the Hawaii state assessment were instead offered
- 8 to third and fourth grade ka papahana kaiapuni students. These
- 9 translated assessments contained numerous flaws, including
- 10 inconsistent and inaccurate translations, and as a result,
- 11 failed to accurately measure ka papahana kaiapuni students'
- 12 academic achievement.
- 13 However, according to board of education policy 2105, "the
- 14 program's effectiveness requires the development and proper
- 15 administration of appropriate formative and summative assessment
- 16 tools. These program evaluation tools should be in alignment
- 17 with the State's kaiapuni curriculum and measure student growth
- 18 and proficiency with the goal to prepare students for success in
- 19 college, career and community."
- 20 Act 134, Session Laws of Hawaii 2013, appropriated
- 21 \$1,000,000 to the department of education for the development of

1. "a common core state standards assessment in the Hawaiian 2 language." In 2014, the department of education entered into a 3 three-year memorandum of agreement with the university of Hawaii 4 to develop non-translated Hawaiian language assessments for ka 5 papahana kaiapuni students in grades three and four. 6 The purpose of this Act is to make an appropriation to 7 support the department of education's continued development of 8 non-translated assessments in the Hawaiian language, and to 9 require the department of education to report on the status of 10 annual non-translated assessments in the Hawaiian language for 11 language arts, mathematics, and science subjects, in accordance 12 with federal accountability assessment requirements, to be **13** administered to ka papahana kaiapuni students in certain grades and to develop a long-term plan to administer the assessments. 14 15 SECTION 2. No later than twenty days prior to the 16 convening of the regular sessions of 2016 and 2017, the 17 department of education shall prepare and submit a preliminary 18 and a final report, respectively, to the legislature on: 19 (1) The status of the development and administration of 20 the non-translated Hawaiian language assessments

1	(2) The status of federal compliance issues relating to
2	the non-translated Hawaiian language assessments,
3	including the status of any waivers sought from the
4	United States Department of Education; and
5	(3) Any other actions taken to comply with this Act;
6	provided that the final report include the department's long-
7	term plan to develop and administer non-translated Hawaiian
8	language assessments, for each of the grade levels required for
9	federal accountability purposes, including funding projections
10	and any federal compliance issues.
11	SECTION 3. There is appropriated out of the general
12	revenues of the State of Hawaii the sum of \$ or so
13	much thereof as may be necessary for fiscal year 2015-2016 and
14	the same sum or so much thereof as may be necessary for fiscal
15	year 2016-2017 for the continued development of non-translated
16	assessments in the Hawaiian language and to report on the status
17	and long-term development and administration of annual non-
18	translated assessments in the Hawaiian language.
19	The sums appropriated shall be expended by the department
20	of education for the purposes of this Act.
21	SECTION 4. This Act shall take effect on July 1, 2050.
