A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION FOR GENERAL ASSISTANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. Act 122, Session Laws of Hawaii 2014,
- 5 appropriated a certain designated sum to the department of human
- 6 services to provide funds for the general assistance program
- 7 under the benefit, employment and support services division for
- 8 the fiscal period beginning July 1, 2014, and ending June 30,
- **9** 2015.
- 10 A critical funding emergency exists. Pursuant to section
- 11 346-53(b), Hawaii Revised Statutes, the general assistance
- 12 program is a block grant program; the maximum allowance a
- 13 general assistance recipient may receive is determined by
- 14 dividing the amount of the appropriation received by the total
- 15 number of general assistance recipients. The general assistance
- 16 program will expend all appropriated funds before the end of the
- 17 current fiscal year and the department will be unable to

- 1 maintain the current maximum \$348 per month general assistance
- 2 payment benefit to approximately 5,752 (the average General
- 3 Assistance caseload for July November 2014) disabled
- 4 recipients. The current assistance grant for disabled
- 5 individuals is based on 37.1 per cent of the 2006 federal
- 6 poverty level. This amount is barely enough to cover living
- 7 expenses for individuals on a fixed income who have no other
- 8 viable means of support. Stopping the grant payment or reducing
- 9 the amount of the grant payment for these individuals poses a
- 10 real threat to the individuals' health and safety. To prevent
- 11 the reduction of general assistance payments in the fourth
- 12 quarter of fiscal year 2014-2015, additional funds are urgently
- 13 needed.
- 14 SECTION 3. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so much
- 16 thereof as may be necessary for fiscal year 2014-2015 to be used
- 17 for general assistance payments.
- 18 The sum appropriated shall be expended by the department of
- 19 human services for the purposes of this Act.
- 20 SECTION 4. This Act shall take effect upon its approval.
