A BILL FOR AN ACT

RELATING TO DUAL CREDIT PROGRAMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

The Georgetown University Center on Education 1 SECTION 1. and the Workforce has projected that, by 2020, seventy per cent 2 3 of jobs in Hawaii will require that employees have some 4 postsecondary education. However, according to the United States Census, currently, just forty-two per cent of Hawaii's 5 adults hold a two- or four-year college degree. Several 6 national and local studies have shown the effectiveness of dual 7 credit programs (programs in which students earn both high 8 9 school and college credit simultaneously) on rates at which 10 students go to, stay in, and graduate from college with a 11 postsecondary degree or certificate.

12 A study recently conducted by Hawaii P-20 Partnerships for 13 Education on current dual credit programs, such as running 14 start, show similar gains for students taking college-level 15 courses while still in high school, despite the high financial 16 cost to students and their families. Nationally, of the forty-17 seven states (plus the District of Columbia) that have statewide

policies governing at least one dual credit program, Hawaii is
 one of only nine states that requires payment for participation
 in a dual credit program.


Increasing numbers of students in Hawaii are taking dual 4 5 credit courses through programs that include the running start, jump start, or early college high school programs. However, 6 maximizing the available credits and the opportunity for 7 students to earn both an associate degree and a high school 8 diploma, requires that academically prepared students be allowed 9 to start during their first year of high school. This will 10 bring Hawaii in line with over twenty-eight states that 11 currently allow college-ready high school students to begin 12 13 taking dual credit courses in ninth grade.

14 Finally, there is a growing trend for student assessment of 15 college-readiness, not by a single standardized test, but by 16 multiple measurements such as grades, overall grade point 17 average, teacher recommendations, and various assessments and 18 tests.

19 The purpose of this Act is to broaden current law to
20 include all dual credit programs, to broaden eligibility of
21 students, to allow for multiple measures of eligibility

1 assessment, and to appropriate funds for the instruction, courses, and administration of college credits, thus allowing 2 3 broader student participation in dual credit programs. 4 SECTION 2. Section 302A-401, Hawaii Revised Statutes, is 5 amended to read as follows: "§302A-401 [Running-start program.] Dual credit programs. 6 7 There [is] are created in the department [the running start (a) program] dual credit programs to permit eligible students to 8 9 enroll in any qualified course offered by the University of 10 Hawaii system. For the purposes of this section: 11 (b) "Eligible student" means a high school student [in the 12 13 eleventh or twelfth grade] who: 14 (1) Has passed [a standardized test administered] an assessment approved by the college that demonstrates 15 the student's ability to succeed at the college level; 16 Is under the age of twenty-one as of September 1 of 17 (2) the school year in which the college course is taken; 18 19 and Has other qualifications deemed appropriate by the 20 (3)

provided that subsequent qualifications do not 1 2 restrict any student from taking the [standardized 3 test.] assessment. 4 "Qualified course" means any vocational or academic course 5 offered by the University of Hawaii system that also applies to 6 the department's graduation requirements or is otherwise 7 permitted by department rule or policy. 11 SECTION 4. There is appropriated out of the general 12 revenues of the State of Hawaii the sum of \$1,840,000 or so much 13 thereof as may be necessary for fiscal year 2015-2016 and the 14 same sum or so much thereof as may be necessary for fiscal year 15 2016-2017 to provide the department of education with two full-16 time equivalent (2.0 FTE) positions, and resources to carry out 17 the purposes of this Act.

18 The sums appropriated shall be expended by the department 19 of education.

20 SECTION 5. There is appropriated out of the general
21 revenues of the State of Hawaii the sum of \$800,000 or so much



1 thereof as may be necessary for fiscal year 2015-2016 and the 2 same sum or so much thereof as may be necessary for fiscal year 3 2016-2017 to provide the University of Hawaii with one full-time 4 equivalent (1.0 FTE) position, and resources to carry out the 5 purposes of this Act.

6 The sums appropriated shall be expended by the University7 of Hawaii.

8 SECTION 6. Statutory material to be repealed is bracketed9 and stricken. New statutory material is underscored.

10 SECTION 7. This Act shall take effect upon its approval.
