BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 286-111, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"§286-111 Application for license, provisional license,
4	or instruction permit; fees. (a) Every application for an
5	instruction permit, provisional license, or driver's license
6	shall be made upon a form furnished by the examiner of drivers
7	and shall be verified by the applicant before a person
8	authorized to administer oaths. The examiner of drivers and
9	officers serving under the examiner may administer the oaths
10	without charge. Each application for an instruction permit for
11	a category (1), (2), (3), or (4) license shall be accompanied by
12	a fee to be determined by the council of each county, and each
13	application for a provisional license or driver's license shall
14	be accompanied by the fee, unless the applicant has already paid
15	the fee upon application for an instruction permit in the same
16	county, in which event no fee shall be charged. An additional
17	fee to be determined by the council of each county shall be
18	charged and collected upon the issuance of a provisional license

JUSTIFICATION SHEET

DEPARTMENT: Transportation

TITLE: A BILL FOR AN ACT RELATING TO DRIVER

LICENSING.

PURPOSE: To amend the law relating to fees charged to

driver's license applicants.

MEANS: Amend section 286-111, Hawaii Revised

Statutes.

JUSTIFICATION: The computer equipment used in Hawaii's

driver licensing program has become quite sophisticated during the State's move to comply with Real ID requirements. For example, many of the documents that are presented by applicants can be scanned and

quickly authenticated to ensure the applicant's true identity. However, to

continue to meet the needs of the licensing program, the computers and software need to be maintained and updated regularly so they are abreast of changes that are made to official documents that are used not only in this country but in many other countries around the world. Although federal funding

was used for the acquisition and initial maintenance and update costs, the State must absorb the continuing costs and future updates. Giving the director authority to

establish a small application fee can

accomplish this.

Impact on the public: The maintenance fee will be less than a dollar, so it will have virtually no financial impact on the public, and the driver's license document will continue to be of high integrity and credibility.

Impact on the department and other agencies: The department will be able pay for the software maintenance and upgrades. No anticipated impact on other agencies.
