
HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF EDUCATION TO CONDUCT A TWO-YEAR
PILOT PROJECT TO IMPLEMENT CONTRACTS FOR SERVICES FOR
STUDENTS WITH DISABILITIES ON A BLOCK BASIS RATHER THAN ON
A ONE-TO-ONE BASIS.

1 WHEREAS, the Department of Education provides contract
2 services on a one-to-one basis for students with disabilities
3 who have complex needs; and
4

5 WHEREAS, these contract services are under the supervision
6 of the classroom teacher; and
7

8 WHEREAS, the Department of Education has a rationale for
9 providing contracts in this manner; and
10

11 WHEREAS, one-to-one services preclude children with
12 disabilities from group instruction on academic, social,
13 communication, and behavioral skills; and
14

15 WHEREAS, evidence demonstrates that students with one-to-
16 one services throughout the school day may become overly
17 dependent on the adult support person; and
18

19 WHEREAS, a disproportionate student to adult ratio
20 obstructs student learning, inhibits peer-to-peer interaction,
21 and is not cost effective; and
22

23 WHEREAS, the current practice of contracting for one-to-one
24 services appears to be a deterrent to more inclusive practices;
25 and

27 WHEREAS, contracted services could be provided on a
28 different basis; and

1 WHEREAS, purchasing services in a block allows for more
2 flexibility in meeting the needs of students with disabilities;
3 now, therefore,
4

5 BE IT RESOLVED by the House of Representatives of the
6 Twenty-eighth Legislature of the State of Hawaii, Regular
7 Session of 2016, the Senate concurring, that the Department of
8 Education is requested to conduct a two-year pilot project to
9 implement contracts for services for students with disabilities
10 on a block basis rather than the current one-to-one basis; and
11

12 BE IT FURTHER RESOLVED that the Department of Education is
13 requested to convene a working group to include parents and
14 community stakeholders including:
15

- 16 (1) One parent from a school in a rural complex area;
17
- 18 (2) One parent from a school in an urban complex area;
19
- 20 (3) One parent from a Title I school;
21
- 22 (4) One member from the Special Education Advisory
23 Council;
24
- 25 (5) One member from the Coalition of Children with Special
26 Needs;
27
- 28 (6) One member from the Community Children's Council; and
29
- 30 (7) One member from the State Council on Developmental
31 Disabilities; and
32

33 BE IT FURTHER RESOLVED that the working group is requested
34 to assist the Department of Education to:
35

- 36 (1) Determine the nature of services that could be
37 contracted by a block of time to serve more than one
38 student with disabilities;

- 40 (2) Select, in coordination with the Department of
41 Education, three school sites; one school from a rural
42 complex area, one school from an urban complex area,

1 and one Title I school, to pilot the adaptation of
2 existing contracts utilizing blocks of time and
3 greater scheduling flexibility in the delivery of
4 services; and
5

- 6 (3) Conduct a cost-benefit analysis of the delivery of
7 services to students with complex needs utilizing a
8 block contract model and an employee-based model; and
9

10 BE IT FURTHER RESOLVED that the Department of Education is
11 requested to submit a progress report of the impact of the
12 revised contract methodology on the academic, social,
13 communication, and behavioral progress of the students served to
14 the Legislature no later than twenty days prior to the convening
15 of the Regular Session of 2017; and
16

17 BE IT FURTHER RESOLVED that the Department of Education is
18 requested to submit a final report of its findings and
19 recommendations, including any proposed legislation, to the
20 Legislature no later than twenty days prior to the convening of
21 the Regular Session of 2018; and
22

23 BE IT FURTHER RESOLVED that certified copies of this
24 Concurrent Resolution be transmitted to the Chairperson of the
25 Board of Education, Superintendent of Education, Chairperson of
26 the Special Education Advisory Council, Chairperson of the
27 Coalition of Children with Special Needs, Administrator of the
28 Community Children's Council Office, and Executive Administrator
29 of the State Council on Developmental Disabilities.
