## HOUSE RESOLUTION

SUPPORTING GAME MAMMAL, GAME BIRD, AND FISHING RESOURCES IN ORDER TO PROMOTE SUSTAINABILITY AND FOOD SECURITY AND TO PRESERVE LONG STANDING LOCAL AND CULTURAL PRACTICES.

WHEREAS, Hawaii imports between eighty-five and ninety 1 percent of its food, and in the event of a natural disaster or 2 global event that prevents food shipment, Hawaii could face a 3 devastating food shortage; and 4 5 WHEREAS, the practices of fishing and hunting have a long 6 7 history in the culture of Hawaii; and 8 WHEREAS, today, the availability of fresh, locally-caught 9 fish is a basic expectation in our communities; and 10 11 WHEREAS, residents on the island of Molokai receive 12 approximately forty percent of their daily sustenance from 13 subsistence sources such as fishing, hunting, and backyard 14 farming; and 15 16 WHEREAS, the residents of the island of Hawaii harvest up 17 to 1,000,000 pounds of game each year; and 18 19 WHEREAS, game mammals and game birds are a sustainable food 20 source, and our State's unique relationship with the ocean 21 allows us the opportunity to integrate the local fish and game 22 industry into our food security profile; and 23 24 25 WHEREAS, policies on conservation and protection of terrestrial and marine resources should promote the concept that 26 27 game mammals, game birds, and marine resources are an integral part of our island culture; now, therefore, 28 29 BE IT RESOLVED by the House of Representatives of the 30 Twenty-eighth Legislature of the State of Hawaii, Regular 31 32 Session of 2016, that this body urges the conservation,

development, and utilization of game mammal, game bird, and 1 2 fishing resources; and 3 BE IT FURTHER RESOLVED that this body recognizes that 4 pioneered introductions, such as the pig, and later 5 sustainability introductions, such as goats, sheep, and deer, 6 are now recognized as game mammal and game bird resources and 7 8 should be included among the game management resources supported 9 to achieve sustainability and food security; and 10 BE IT FURTHER RESOLVED that this body urges state 11 departments to develop and update their rules and policies to 12 integrate the local hunting and fishing industries into any food 13 14 security or sustainability strategies they employ and to 15 preserve, protect, and promote these industries and local cultural practices to nurture them into viable and sustainable 16 economic, nutritional, and cultural resources; and 17 18 19 BE IT FURTHER RESOLVED that certified copies of this 20 Resolution be transmitted to the Chairperson of the Board of Agriculture and the Chairperson of the Board of Land and Natural 21 22 Resources.
