HOUSE RESOLUTION

REQUESTING THE CONVENING OF A TASK FORCE TO EXPLORE THE MERGING OF THE OAHU INTERSCHOLASTIC ASSOCIATION AND INTERSCHOLASTIC LEAGUE OF HONOLULU HIGH SCHOOL FOOTBALL LEAGUES.

WHEREAS, the State has an interest in developing and supporting high school athletics; and

WHEREAS, alumni and students demonstrate unwavering school spirit and commitment to their high school football teams; and

WHEREAS, the high schools in the State have a strong and ongoing rivalry between their respective football teams; and

WHEREAS, the division between the Oahu Interscholastic Association and Interscholastic League of Honolulu makes it difficult to determine outright champions in Oahu football competitions; and

WHEREAS, the merging of the Oahu Interscholastic Association and Interscholastic League of Honolulu may provide benefits both fiscally and competitively; now, therefore,

BE IT RESOLVED by the House of Representatives of the Twenty-eighth Legislature of the State of Hawaii, Regular Session of 2016, that the Legislature convene a task force to explore merging the Oahu Interscholastic Association and Interscholastic League of Honolulu high school football leagues; and

BE IT FURTHER RESOLVED that Lieutenant Governor, or his or her designee, is requested to serve as the Chairperson of the task force to invite interested parties to be members of the task force, including:
