A BILL FOR AN ACT

RELATING TO CHAPTER 245, HAWAII REVISED STATUTES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the public health 2 rationale for the regulation of cigarettes and tobacco products 3 is well developed, as tobacco use is the single most preventable 4 cause of disease, disability, and death in the United States. 5 In addition to substantive laws in the State governing specific aspects of tobacco production, sales, and use, Hawaii law 6 7 requires retailers, wholesalers, and dealers of cigarettes or 8 tobacco products to obtain a special license or permit. These licenses and permits facilitate the enforcement of the cigarette 9 tax and tobacco tax law under chapter 245, Hawaii Revised 10 11 However, the current license fee for wholesalers and Statutes. 12 dealers is only \$2.50 a year, while retail tobacco permit fees 13 cost only \$20 a year. To ensure continued tobacco regulation 14 and enforcement of relevant tax laws, the legislature concludes 15 that these fees should be increased.

1	the permit fees collected under this subsection shall be used to
2	support smoking cessation programs in the State. Whenever a
3	retail tobacco permit is defaced, destroyed, or lost, or the
4	permittee relocates the permittee's business, the department may
5	issue a duplicate retail tobacco permit to the permittee for a
6	fee of \$5 per copy."
7	SECTION 5. Statutory material to be repealed is bracketed
8	and stricken. New statutory material is underscored.
9	SECTION 6. This Act shall take effect upon its approval.
