# A BILL FOR AN ACT

RELATING TO INVASIVE SPECIES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that the interisland
3	spread of invasive spécies is harmful to agriculture, native
4	biota, public health, and the economic well-being of the State.
5	Further, the legislature finds that these pests continue to move
6	to new areas within the State through varied transportation
7	methods and on various agricultural and non-agricultural
8	commodities, which may or may not be subject to inspection for
9	pests or subject to treatment.
10	To more effectively mitigate the spread of invasive
11	species, the Hawaii invasive species council and the biosecurity
12	program of the department of agriculture should use their
13	strengths and resources more efficiently. The Hawaii invasive
14	species council should direct the invasive species committees to
15	focus their resources on reducing invasive species in non-
16	agricultural areas, specifically conservation lands and
17	residential areas. The department of agriculture should focus

1	its resources on reducing invasive species in agricultural
2	production areas and performing inspections, certifications, and
3	treatments, if required.
4	SECTION 2. The department of agriculture shall work
5	through existing contracts and appropriated funds for invasive
6	species activities to undertake invasive species management
7	related to agricultural lands and agricultural and non-
8	agricultural commodities as follows:
9	(1) The department of agriculture shall use funds from the
10	pest inspection, quarantine, and eradication fund to:
11	(A) Develop an interisland and export database that
12	allows for the trace-back and trace-forward of
13	agricultural commodities, type and varietals
14	inspected by the department of agriculture,
15	quantity of commodities, and other pertinent
16	information. All information shall be kept
17	confidential to the plant quarantine branch;
18	(B) Provide a risk level assessment for the various
19	non-agricultural commodities being transported
20	interisland for specific pests based on collected

data and scientific analysis to determine risk;

1		(C)	Increase the priority of inspection of
2			agricultural commodities transported between
3			islands, without impacting or jeopardizing the
4			inspection of imported agricultural commodities
5			from out-of-state;
6		(D)	Develop quarantine treatments for high-risk
7			commodities moving between islands; and
8		(E)	Coordinate planning with the department of
9			transportation for inspection and quarantine
10			treatment capabilities at or adjacent to ports of
11			entry; and
12	(2)	The	department of agriculture shall use funds from the
13		agri	cultural development and food security special
14		fund	to:
15		(A)	Implement pest management programs statewide in
16			potted plant production, cut-flower and cut-
17			foliage production, fruit and nut crops, and
18			vegetable and herb crops; and
19		(B)	Provide chemicals and equipment to assist growers
20			in reducing infestation in agricultural areas,
21			statewide.

T	SECTION 3. The Hawaii invasive species council shall work
2	through existing contracts and use appropriated funds for
3	invasive species activities to undertake invasive species
4	management on non-agricultural lands to:
5	(1) Reduce infestation levels of invasive species on
6	conservation lands near or adjacent to Hilo harbor,
7	Hilo International Airport, and agricultural
8	production areas in the county of Hawaii; and
9	(2) Create buffer areas between conservation lands and
10	agricultural production areas in the county of Hawaii
11	to prevent re-infestation of invasive species onto
12	agricultural lands after pest management programs are
13	established in agricultural production areas.
14	SECTION 4. The department of agriculture shall submit an
15	annual report to the legislature no later than twenty days prior
16	to the convening of the regular session of 2016 and every
17	regular session thereafter. In addition to any forms, reports,
18	and other submittals from the department of accounting and
19	general services that relate to the subject matter of this Act,
20	the report by the department of agriculture shall include, but

16	SECT	ION 5. The Hawaii invasive species council shall
17	submit an	annual report to the legislature no later than twenty
18	days prio	r to the convening of the regular session of 2016 and
19	every reg	ular session thereafter. In addition to any forms,
20	reports,	and other submittals from the department of accounting
21	and gener	al services that relate to the subject matter of this

- 1 Act, the report by the Hawaii invasive species council shall 2 include, but not be limited to: 3 The status, workforce allocation, salary expenditures, 4 and other costs related to performing the activities 5 required by this Act; 6 (2) The area, in miles, of established buffer zones; 7 (3) The effectiveness of reducing or eliminating pests 8 around Hilo harbor and Hilo International Airport; 9 (4)The number of acres adjacent to agricultural 10 production areas that have been treated and included 11 in mitigation activities, including the degree of 12 treatment and mitigation; and 13 (5) Projections by year of future areas to be treated and 14 miles of buffer zones to be added. 15 SECTION 6. There is appropriated out of the pest 16 inspection, quarantine, and eradication fund the sum of **17** or so much thereof as may be necessary for fiscal year **18** 2015-2016 for the purposes set forth in section 2(1) of this
- The sum appropriated shall be expended by the department of agriculture for the purposes of this Act.

- 1 SECTION 7. There is appropriated out of the agricultural
- 2 development and food security special fund the sum of \$
- 3 or so much thereof as may be necessary for fiscal year 2015-2016
- 4 for the purposes set forth in section 2(2) of this Act.
- 5 The sum appropriated shall be expended by the department of
- 6 agriculture for the purposes of this Act.
- 7 SECTION 8. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$ or so much
- 9 thereof as may be necessary for fiscal year 2015-2016 for the
- 10 purposes set forth in section 3 of this Act.
- 11 The sum appropriated shall be expended by the Hawaii
- 12 invasive species council for the purposes of this Act.
- 13 PART II
- 14 SECTION 9. The department of agriculture shall develop and
- 15 implement a pilot pesticide treatment coupon project within its
- 16 current little fire ant program. The pilot project shall
- 17 distribute coupons redeemable for appropriate pesticide at
- 18 suppliers or vendors within the county of Hawaii at no cost to
- 19 individuals who have reported and verified to the department the
- 20 presence of little fire ants on their property within the county

- 1 of Hawaii. Each coupon shall be valid for a one-year supply of
- 2 the department's recommended treatment plan.
- 3 SECTION 10. The department of agriculture shall create a
- 4 map that indicates all little fire ant sites in the county of
- 5 Hawaii by using all its available data, including verified
- 6 reports of little fire ant sites. The maps shall be updated
- 7 periodically and made available on the department's website.
- 8 SECTION 11. The department of agriculture shall submit a
- 9 report on its progress in implementing the mandates in sections
- 10 9 and 10 of this Act to the legislature no later than twenty
- 11 days prior to the convening of the regular sessions of 2016 and
- 12 2017. The report shall include findings and recommendations,
- 13 any necessary proposed legislation, and whether the pilot
- 14 project in section 9 and little fire ant site map in section 10
- 15 of this Act should be continued, terminated, or modified.
- 16 SECTION 12. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ or so much
- 18 thereof as may be necessary for fiscal year 2015-2016 and the
- 19 same sum or so much thereof as may be necessary for fiscal year
- 20 2016-2017 for the little fire ant pilot project in section 9 and
- 21 the little fire ant site map in section 10 of this Act.

- 1 The sums appropriated shall be expended by the department
- 2 of agriculture for the purposes of this Act.
- 3 PART III
- 4 SECTION 13. This Act shall take effect on July 1, 2030.

### Report Title:

Invasive Species; Department of Agriculture; Hawaii Invasive Species Council; Appropriation; Little Fire Ant; Pesticide Treatment Coupon Pilot Project; Little Fire Ant Site Map

#### Description:
