# A BILL FOR AN ACT

RELATING TO STARLIGHT RESERVE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Act 161, Session Laws of Hawaii 2009, is
2	amended by amending subsection (a) of section 2 to read as
3	follows:
4	"(a) The department of business, economic development, and
5	tourism shall develop a statewide starlight reserve strategy.
6	The department of business, economic development, and tourism
7	shall be assisted by a temporary advisory committee, to be
8	placed within the department for administrative purposes. The
9	members of the temporary advisory committee shall consist of:
10	(1) The director of [the-department of] business, economic
11	development, and tourism or the director's designee;
12	(2) The comptroller or the comptroller's designee;
13	(3) The director of the institute for astronomy of the
14	University of Hawaii or the director's designee;
15	(4) The director of health or the director's designee;
16	(5) The director of transportation or the director's

Extends the existence of the Starlight Reserve Advisory Committee until June 30, 2021. Amends the Office of Hawaiian Affairs' representative on the committee. Requires the Starlight Reserve Advisory Committee to report to the Legislature prior to the regular sessions of 2017 and 2019. (SB1157 HD1)
