A BILL FOR AN ACT

RELATING TO THE HAWAII STATE HOSPITAL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the senate special
2	investigative committee on the Hawaii state hospital (special
3	investigative committee) was established pursuant to S.R. No. 3
4	(Regular Session of 2014). The purpose of the special
5	investigative committee was to investigate the workplace safety
6	of all Hawaii state hospital psychiatric workers and alleged
7	improprieties concerning administrative and employment matters
8	at the Hawaii state hospital, and submit its written findings
9	and recommendations to the legislature.
,10	As a result of its investigation, the special investigative
11	committee found that the Hawaii state hospital faces three main
12	interrelated challenges:
13	(1) Maintaining a safe work environment for Hawaii state
14	hospital staff;
15	(2) Meeting the current needs of Hawaii state hospital
16	patients and staff due to inefficient use of
17	facilities and patient and staff safety practices; and

1	(3)	Providing efficient and effective human resources
2		practices.
3	The speci	al investigative committee submitted a written report
4	of its fi	ndings and recommendations to the legislature on
5	October 2	3, 2014.
6	The	purpose of this Act is to:
7	(1)	Require the department of health and Hawaii state
8		hospital to implement certain recommendations made by
9		the special investigative committee;
10	(2)	Require the department of health and Hawaii state
11		hospital to submit a written report to the legislature
12		of its status of implementing certain recommendations
13		prior to the regular sessions of 2016 and 2017; and
14	(3)	Appropriate funds to the department of health for the
15	•	planning and design of a new state forensic mental
16		health hospital.
17	SECT	ION 2. (a) Pursuant to the final report of the senate
18	special i	nvestigative committee on the Hawaii state hospital,
19	the depar	tment of health and Hawaii state hospital shall carry
20	out the f	ollowing recommendations:

11		(G)	Construct a fence around the perimeter of the
12			Hawaii state hospital campus to ensure safety for
13			the surrounding community and assist in
14			preventing patient elopements; and
15		(H)	Develop procedures to alert the community when a
16			patient elopement occurs; and

19		(A)	Collaborate with the department of health to
20			streamline internal recruitment and hiring

19	of the regular	session of 2016. The department of health and		
20	Hawaii state h	ospital shall submit a written final report,

- 1 legislature regarding its efforts in, completion of, and
- 2 impediments to implementing the recommendations under subsection
- 3 (a), no later than twenty days prior to the convening of the
- 4 regular session of 2017.
- 5 SECTION 3. The director of finance is authorized to issue
- 6 general obligation bonds in the sum of \$15,000,000 or so much
- 7 thereof as may be necessary and the same sum or so much thereof
- 8 as may be necessary is appropriated for fiscal year 2015-2016
- 9 for the planning and design of a state forensic mental health
- 10 hospital.
- 11 The sum appropriated shall be expended by the department of
- 12 health for the purposes of this Act.
- 13 SECTION 4. The appropriation made for the capital
- 14 improvement project authorized by this Act shall not lapse at
- 15 the end of the fiscal biennium for which the appropriation is
- 16 made; provided that all moneys from the appropriation
- 17 unencumbered as of June 30, 2018, shall lapse as of that date.
- 18 SECTION 5. This Act shall take effect on July 1, 2015.
