A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Act 99, Session Laws
- 2 of 2013, established the Hawaii agriculture workforce advisory
- 3 board to advise the department of labor and industrial relations
- 4 on, among other things, projects and programs recommended to
- 5 promote the expansion and development of the State's
- 6 agricultural industry.
- 7 The purpose of this Act is to implement the recommendation
- 8 of the Hawaii agriculture workforce advisory board that the
- 9 State should create an agriculture workforce development
- 10 pipeline initiative to conduct training on all islands for
- 11 teachers and school administrators in agricultural self-
- 12 sufficiency.
- 13 SECTION 2. Chapter 371, Hawaii Revised Statutes, is
- 14 amended by adding a new section to be appropriately designated
- 15 and to read as follows:
- 16 "\$371- K-12 agriculture workforce development pipeline
- 17 initiative. (a) There shall be created in the department of

5	(b) The k-12 agriculture workforce development pipeline
6	initiative shall be headed by a coordinator who shall be
7	appointed by the director of labor and industrial relations,
8	subject to chapter 76. The coordinator shall develop and
9	propose incentives, including scholarships, travel offsets,
10	course credits, and stipends. The coordinator may hire, subject
11	to chapter 76, necessary staff, including a workforce
12	development specialist, to carry out the purposes of this
13	section.
14	(c) Course material for the training sessions under
15	subsection (a) shall be approved by the Hawaii agriculture
16	workforce advisory board established pursuant to section 371-19.
17	(d) The department of labor and industrial relations shall
18	submit annual reports to the legislature on the activities of
19	the k-12 agriculture workforce development pipeline initiative.
20	SECTION 3. There is appropriated out of the general

revenues of the State of Hawaii the sum of \$500,000 or so much

- 1 thereof as may be necessary for fiscal year 2015-2016 and the
- 2 same sum or so much thereof as may be necessary for fiscal year
- 3 2016-2017 for the development, operation, and implementation of
- 4 the K-12 agriculture workforce development pipeline initiative,
- 5 including the hiring of a full-time equivalent (FTE) coordinator
- 6 and a full-time equivalent (FTE) workforce development
- 7 specialist.
- 8 The sums appropriated shall be expended by the department
- 9 of labor and industrial relations for the purposes of this Act.
- 10 SECTION 4. New statutory material is underscored.
- 11 SECTION 5. This Act shall take effect on July 1, 2015.
