A BILL FOR AN ACT

RELATING TO AFFORDABLE HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that affordable housing
3	is a serious concern for many Hawaii residents. According to
4	the 2011 Hawaii housing planning study, up to 50,000 new housing
5	units will need to be built by 2016 to meet the new demand
6	generated by changing demographics and economic conditions.
7	Failure to produce sufficient units for low- and moderate-income
8	households will cause pent-up demand in these market segments.
9	The legislature also finds that according to the Hawaii
10	public housing authority annual report for fiscal year 2014, the
11	Hawaii public housing authority's fifty-year-old public housing
12	stock is in need of repairs, with a backlog estimated at
13	\$754,000,000.
14	The purpose of this Act is to appropriate funds to various
15	housing agencies to increase the supply of affordable and public
16	housing units in the State and to support the State's housing
17	first programs in assisting Hawaii's chronically homeless who

- 1 are often the most vulnerable, most visible, and most difficult
- 2 to serve.
- 3 PART II
- 4 SECTION 2. The director of finance is authorized to issue
- 5 general obligation bonds in the sum of \$60,000,000 or so much
- 6 thereof as may be necessary and the same sum or so much thereof
- 7 as may be necessary is appropriated for fiscal year 2015-2016
- 8 for deposit into the rental housing trust fund established
- 9 pursuant to section 201H-202, Hawaii Revised Statutes.
- 10 SECTION 3. There is appropriated out of the rental housing
- 11 trust fund the sum of \$60,000,000 or so much thereof as may be
- 12 necessary for fiscal year 2015-2016 for the purposes set forth
- in section 201H-202, Hawaii Revised Statutes.
- 14 The sum appropriated shall be expended by the Hawaii
- 15 housing finance and development corporation for the purposes of
- 16 this part.
- 17 PART III
- 18 SECTION 4. The director of finance is authorized to issue
- 19 general obligation bonds in the sum of \$20,000,000 or so much
- 20 thereof as may be necessary and the same sum or so much thereof
- 21 as may be necessary is appropriated for fiscal year 2015-2016 to

- 1 be deposited into the dwelling unit revolving fund established
- 2 pursuant to section 201H-191, Hawaii Revised Statutes.
- 3 SECTION 5. There is appropriated out of the dwelling unit
- 4 revolving fund the sum of \$20,000,000 or so much thereof as may
- 5 be necessary for fiscal year 2015-2016 for the development of
- 6 infrastructure and improvements of on-site and off-site
- 7 development.
- 8 The sum appropriated shall be expended by the Hawaii
- 9 housing finance and development corporation for the purposes of
- 10 this part.
- 11 PART IV
- 12 SECTION 6. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$15,000,000 or so
- 14 much thereof as may be necessary for fiscal year 2015-2016 and
- 15 the same sum or so much thereof as may be necessary for fiscal
- 16 year 2016-2017 for the construction of micro apartment housing
- 17 units.
- 18 For the purposes of this part, "micro apartment housing
- 19 unit" means a dwelling unit with a total floor area of not less
- 20 than two hundred twenty square feet, and not more than three
- 21 hundred twenty square feet for not more than two occupants, and

- 1 containing a separate closet, kitchen sink, cooking appliance,
- 2 refrigeration facilities, and separate bathroom containing a
- 3 toilet and a bathtub or shower. The minimum and maximum total
- 4 floor area shall increase an additional one hundred square feet
- 5 for each occupant in excess of two.
- 6 The sums appropriated shall be expended by the Hawaii
- 7 housing finance and development corporation for the purposes of
- 8 this part.
- 9 PART V
- 10 SECTION 7. The legislature finds that housing first
- 11 programs are a collaborative effort between the department of
- 12 human services and the United States Department of Housing and
- 13 Urban Development that provides housing and support services for
- 14 the chronically homeless, including those who have an addiction
- 15 or mental illness, or both. The principles of housing first
- 16 programs include:
- 17 (1) Moving the chronically homeless into housing directly
- from streets and the shelters without a precondition
- of accepting or complying with treatment;

1	(2)	Providing robust support services for program	
2		participants that are predicated on assertive	
3		engagement rather than coercion;	
4	(3)	Granting the chronically homeless priority as program	
5		participants in housing first programs;	
6	(4)	Embracing a harm-reduction approach to addictions	
7		rather than mandating abstinence while supporting	
8		program participant commitments to recovery; and	
9	(5)	Providing program participants with leases and tenant	
10		protections as provided by law.	
11	The	housing first programs in the State closely resemble	
12	the requirements of the United States Department of Housing an		
13	Urban Development shelter plus care program and the Veterans		
14	Administration veteran's assisted supportive housing voucher		
15	program for homeless veterans. In its December 2011 report to		
16	the legislature pursuant to section 346-378, Hawaii Revised		
17	Statutes,	the department of human services reported that the	
18	State has	six hundred fifty-eight permanent housing placements	
19	plus supp	ort services through the shelter plus care and	
20	veteran's	assisted supportive housing voucher programs.	

1 The purpose of this part is to appropriate funds to the 2 department of human services to support the State's housing 3 first programs in assisting Hawaii's chronically homeless who 4 are often the most vulnerable, most visible, and most difficult 5 to serve. SECTION 8. There is appropriated out of the general 6 7 revenues of the State of Hawaii the sum of \$3,000,000 or so much 8 thereof as may be necessary for fiscal year 2015-2016 and the 9 same sum or so much thereof as may be necessary for fiscal year 2016-2017 to be deposited to the credit of the housing first 10 11 special fund established under section 346-377, Hawaii Revised 12 Statutes, for the department of human services to continue to administer housing first programs for chronically homeless in 13 14 the State. SECTION 9. There is appropriated out of the housing first 15 16 special fund the sum of \$3,000,000 or so much thereof as may be necessary for fiscal year 2015-2016 and the same sum or so much 17 18 thereof as may be necessary for fiscal year 2016-2017 for the 19 department of human services to continue to administer housing **20** first programs for chronically homeless in the State.

- 1 The sums appropriated shall be expended by the department
- 2 of human services for the purposes of this part.
- 3 PART VI
- 4 SECTION 10. The appropriations made in parts II and III of
- this Act shall not lapse at the end of the fiscal biennium for 5
- 6 which the appropriation is made; provided that all moneys from
- 7 the appropriation unencumbered as of June 30, 2018, shall lapse
- as of that date. 8
- 9 SECTION 11. This Act shall take effect on July 1, 2015.

Description:

Authorizes the issuance of general obligation bonds and the appropriation of funds for deposit into the rental housing trust fund and the dwelling unit revolving fund to finance affordable rental housing development and infrastructure development. Appropriates funds for the construction of micro apartment housing units. Appropriates funds to the department of human services to continue to administer housing first programs for chronically homeless.
