A BILL FOR AN ACT

PART I

RELATING TO AFFORDABLE HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	SECTION 1. The legislature finds that affordable housing
3	is a serious concern for many Hawaii residents. According to
4	the 2011 Hawaii Housing Planning Study, up to 50,000 new housing
5	units will need to be built by 2016 to meet the new demand
6	generated by changing demographics and economic conditions.
7	Failure to produce sufficient units for low- and moderate-income
8	households will cause pent-up demand in these market segments.
9	The legislature also finds that according to the Hawaii
10	Public Housing Authority Annual Report for Fiscal Year 2014, the
11	Hawaii public housing authority's fifty-year-old public housing
12	stock is in need of repairs, with a backlog estimated at
13	\$754,000,000.
14	The purpose of this Act is to appropriate funds to various
15	housing agencies to increase the supply of affordable and public
16	housing units in the State and to support the State's housing
17	first programs in assisting Hawaii's chronically homeless who

- 3 PART II
- 4 SECTION 2. The director of finance is authorized to issue
- 5 general obligation bonds in the sum of \$ or so much
- 6 thereof as may be necessary and the same sum or so much thereof
- 7 as may be necessary is appropriated for fiscal year 2015-2016
- 8 for deposit into the rental housing trust fund established
- 9 pursuant to section 201H-202, Hawaii Revised Statutes.
- 10 SECTION 3. There is appropriated out of the rental housing
- 11 trust fund the sum of \$ or so much thereof as may be
- 12 necessary for fiscal year 2015-2016 for the purposes set forth
- 13 in section 201H-202, Hawaii Revised Statutes.
- 14 The sum appropriated shall be expended by the Hawaii
- 15 housing finance and development corporation for the purposes of
- 16 this part.
- 17 PART III
- 18 SECTION 4. The director of finance is authorized to issue
- 19 general obligation bonds in the sum of \$ or so much
- 20 thereof as may be necessary and the same sum or so much thereof
- 21 as may be necessary is appropriated for fiscal year 2015-2016 to

- 1 be deposited into the dwelling unit revolving fund established
- 2 pursuant to section 201H-191, Hawaii Revised Statutes.
- 3 SECTION 5. There is appropriated out of the dwelling unit
- 4 revolving fund the sum of \$ or so much thereof as may be
- 5 necessary for fiscal year 2015-2016 for the development of
- 6 infrastructure and improvements of on-site and off-site
- 7 development.
- 8 The sum appropriated shall be expended by the Hawaii
- 9 housing finance and development corporation for the purposes of
- 10 this part.
- 11 PART IV
- 12 SECTION 6. The director of finance is authorized to issue
- 13 general obligation bonds in the sum of \$ or so much
- 14 thereof as may be necessary and the same sum or so much thereof
- 15 as may be necessary is appropriated for fiscal year 2015-2016
- 16 for the construction of micro apartment housing units.
- 17 For the purposes of this part, "micro apartment housing
- 18 unit" means a dwelling unit with a total floor area of not less
- 19 than two hundred twenty square feet, and not more than three
- 20 hundred twenty square feet for not more than two occupants, and
- 21 containing a separate closet, kitchen sink, cooking appliance,

- 1 refrigeration facilities, and separate bathroom containing a
- 2 toilet and a bathtub or shower. The minimum and maximum total
- 3 floor area shall increase an additional one hundred square feet
- 4 for each occupant in excess of two.
- 5 The sum appropriated shall be expended by the Hawaii
- 6 housing finance and development corporation for the purposes of
- 7 this part.
- 8 PART V
- 9 SECTION 7. The purpose of this part is to establish the
- 10 housing first voucher program and appropriate funds to the
- 11 department of human services to support the State's housing
- 12 first programs in assisting Hawaii's chronically homeless who
- 13 are often the most vulnerable, most visible, and most difficult
- 14 to serve.
- 15 SECTION 8. Chapter 346, Hawaii Revised Statutes, is
- 16 amended by adding a new section to be appropriately designated
- 17 and to read as follows:
- 18 "§346- Housing first voucher program. (a) There is
- 19 established within the department, the housing first voucher
- 20 program to provide vouchers to provider agencies to assist
- 21 qualified individuals in obtaining rental housing.

1	(b)	The department shall:
2	(1)	Contract with provider agencies or implement programs
3		within the department to locate and obtain rental
4		housing for qualified individuals; and
5	(2)	Refer qualified individuals to provider agencies or
6		department programs with available housing first
7		vouchers.
8	<u>(c)</u>	A provider agency or department program that receives
9	a housing	first voucher under this section shall place qualified
10	individua	ls in rental housing units obtained by the provider
11	agency or	department program and funded by housing first
12	vouchers.	The provider agency or department program shall:
13	(1)	Identify appropriate rental housing units;
14	(2)	Enter into rental contracts with the landlord of the
15		identified units to be occupied by qualified
16		individuals;
17	. (3)	Make direct payments, funded by housing first
18		vouchers, to landlords pursuant to rental contracts
19		and chapter 521;
20	(4)	Place qualified individuals in the rental housing
21		units; and

1	<u>(5)</u>	Provide or arrange for appropriate support services to
2		successfully maintain the qualified individual's
3		tenancy.
4	(d)	The contract between the provider agency or department
5	program a	nd the landlord of the rental housing unit shall be
6	subject t	o chapter 521 and shall include the initial rent of the
7	unit, any	redetermined rent of the unit, the contract term of
8	the unit,	and the rights and responsibilities of the provider
9	agency or	department program, landlord, and tenant.
10	<u>(e)</u>	Any voucher issued under this section shall be
11	retained	by the respective provider agency or department
12	program.	In cases where a rental housing unit vacancy occurs,
13	the provi	der agency or department program shall identify a new
14	qualified	individual to fill the vacancy and shall inform the
15	landlord.	In the case of termination of the rental contract,
16	the landl	ord shall provide notice to the qualified individual
17	and the p	rovider agency or department program pursuant to the
18	terms of	the rental contract and chapter 521. The provider
19	agency or	department program shall identify, obtain, and
20	contract	for a replacement rental housing unit for the displaced
21	qualified	individual

5	(g) The department shall adopt rules in accordance with
6	chapter 91 to implement this section.
7	(h) As used in this section:
8	"Qualified individual" means a chronically homeless
9	individual as defined in section 346-378 whom a provider agency
10	or department program deems qualified for placement in rental
11	housing under this section."
12	SECTION 9. There is appropriated out of the general
13	revenues of the State of Hawaii the sum of \$ or so much

- 7 SECTION 11. The appropriations made in parts II, III, and

- 9 for which the appropriation are made; provided that all moneys
- 10 from the appropriation unencumbered as of June 30, 2018, shall
- 11 lapse as of that date.
- 12 SECTION 12. New statutory material is underscored.
- 13 SECTION 13. This Act shall take effect on July 1, 2050.

Description:

Authorizes the issuance of general obligation bonds and the appropriation of funds to finance affordable rental housing development, infrastructure development, construction of micro apartment housing units, and to continue to administer housing first programs for chronically homeless. Establishes and funds a Housing First Voucher Program in the Department of Human Services. (SB120 HD1)
