A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is a rapidly
- 2 growing population of students with diabetes attending public
- 3 schools. Diabetes often prevents these students from
- 4 participating in school functions and events. Diabetes can also
- 5 adversely affect students' ability to perform routine school
- 6 tasks such as test taking. While many of the symptoms of
- 7 diabetes can be treated and mitigated with timely health
- 8 management measures, such as medication or food intake, current
- 9 school policies and practices fail to accommodate those options
- 10 in an effective manner.
- 11 The legislature finds that diabetes must be managed twenty-
- 12 four hours a day to avoid the potentially life-threatening
- 13 short-term consequences of blood glucose levels that are either
- 14 too high or too low, and to avoid or delay the serious long-term
- 15 complications of high blood glucose levels, which include
- 16 blindness, amputation of limbs, heart disease, and kidney
- 17 failure. Well-managed blood glucose levels enable students with



- 1 diabetes to be more productive and successful in school. In
- 2 order to manage their disease, students with diabetes must have
- 3 access to the means to balance food, medications, and physical
- 4 activity levels while at school and at school-related
- 5 activities.
- 6 Diabetes is generally a self-managed disease, and many
- 7 students with diabetes are able to perform most of their own
- 8 diabetes care tasks. However, some students, because of their
- 9 age, inexperience, or other factors, need help with some or all
- 10 diabetes care tasks. Further, all students with diabetes will
- 11 need assistance in the event of a diabetes-related emergency.
- 12 The school nurse plays a central role in providing or
- 13 facilitating care for a student with diabetes in the school
- 14 setting. All public schools in Hawaii have a health aide, but
- 15 many do not have a full-time nurse on campus. In addition, even
- 16 when a nurse is assigned to a school full-time for a specific
- 17 student requiring nursing services throughout the day, that
- 18 nurse is not available to provide direct care to other students
- 19 requiring nursing services during the school day, during
- 20 extracurricular activities, and on field trips. Because
- 21 diabetes management is needed throughout the school day,

- 1 additional personnel who have completed appropriate training are
- 2 needed at schools to perform diabetes care tasks at school and
- 3 school-related activities so that students with diabetes have
- 4 the same access to educational opportunities that other students
- 5 in Hawaii have.
- 6 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
- 7 amended by adding a new part to be appropriately designated and
- 8 to read as follows:
- 9 "PART . CARE OF STUDENTS WITH DIABETES
- 10 §302A-A Definitions. Whenever used in this part, unless a
- 11 different meaning clearly appears from the context:
- 12 "Diabetes medical management plan" means a plan that
- 13 identifies the health needs of the student, sets forth
- 14 prescribed care to address health needs at school, and is signed
- 15 by the student's personal health care professional and a parent
- 16 or quardian.
- 17 "Nurse" shall have the same definition as in section 457-2
- 18 and shall include any other licensed or registered nurse
- 19 providing care to students with diabetes under this part.

- 1 "School" means any public or charter elementary, middle,
- 2 intermediate, secondary, or high school located within the
- 3 State, including its governing body.
- 4 "School employee" means any person employed by a school or
- 5 by the department of health and assigned to a public or charter
- 6 school, or any subcontractor designated for this function.
- 7 "Trained diabetes care personnel" means any school employee
- 8 or volunteer who is trained to provide services to students as
- 9 provided under this part.
- 10 §302A-B Diabetes training. (a) The department shall
- 11 consult with the department of health and the American Diabetes
- 12 Association to develop and adopt rules pursuant to chapter 91
- 13 for the training of school employees and qualified volunteers to
- 14 provide care to students with diabetes. The rules shall include
- 15 a requirement that each school provide annual diabetes training
- 16 programs for all nurses, trained diabetes care personnel, and
- 17 persons seeking to become trained diabetes care personnel. In
- 18 addition, the guidelines shall address:
- 19 (1) Recognition and treatment of hypoglycemia and
- 20 hyperglycemia;

1	(2)	An understanding of the appropriate actions to be
2		taken when blood glucose levels are outside of the
3		target ranges indicated by the student's medical
4		management plan;
5	(3)	Understanding of a physician's instructions concerning
6		diabetes medication dosages, frequency, and manner of
7		administration;
8	(4)	Performance of finger-stick blood glucose checking,
9		ketone checking, and recording of results;
10	(5)	The administration of insulin and the recording of the
11		results;
12	(6)	Understanding how to perform basic insulin pump
13		functions;
14	(7)	Recognizing diabetes-related complications that
15		require emergency assistance;
16	(8)	Understanding recommended schedules and food intake
17		for meals and snacks, the physical effects of physical
18		activity on blood glucose levels, and actions to be
19		taken in case of schedule disruption;
20	(9)	Understanding of any other appropriate medical
21		procedures and technology that may be developed from

1		time to time for testing, treatment, or care of the
2	:	student with diabetes; and
3	(10)	Understanding of long-term complications of diabetes
4	•	and the importance of teaching students with diabetes
5	•	about self-management skills that shall be supported
6	:	in the school setting as prescribed by the student's
7		diabetes medical management plan.
8	(b)	Each school that has at least one student with
9	diabetes e	nrolled shall provide the training required under
10	subsection	(a) to a minimum of three school employees. If at
11	any time f	ewer than three school employees are available to be
12	trained at	the school, the principal or other school
13	administra	tor shall distribute a written notice to all staff
14	stating th	at it is seeking employees to serve as diabetes care
15	personnel.	The notice shall inform staff of:
16	(1)	The requirement that the school provide diabetes care
17		to students with diabetes and recruit personnel
18	,	willing to be trained to provide diabetes care;
19	(2)	The tasks to be performed;
20	(3)	The voluntary nature of participation;
21	(4)	Training, which will be provided at no cost to staff;

1	(5)	Liability	protections	for	persons	willing	to	be
2		trained;	and					

- (6) Contact information of the coordinator designatedpursuant to subsection (d).
- (c) A school shall not discourage any employee from
 participating in the training program or subject any employee
 who declines to serve as trained diabetes care personnel to any
 penalty or disciplinary action for that decision.
- 9 The nurse or a health care professional with expertise (d) 10 in diabetes care shall coordinate the training outlined under 11 subsection (a). If there is any student with diabetes enrolled 12 at the school before the start of the school year, the school 13 shall hold the training before each school year starts. 14 student with diabetes enrolls in the school or is diagnosed with 15 diabetes after the school year has started and the school has 16 not held the diabetes care training before the start of the 17 school year, the training shall be held no more than thirty days 18 following the student's enrollment or diagnosis.
- 19 (e) Each school shall provide training for all school
 20 employees responsible for the supervision of any student with
 21 diabetes, including bus drivers who transport students with

- 1 diabetes, regarding the recognition of hypoglycemia and
- 2 hyperglycemia and the appropriate action to take in an emergency
- 3 situation.
- 4 §302A-C Diabetes medical management plan. The parent or
- 5 guardian of each student with diabetes who seeks diabetes care
- 6 for the student while at school shall submit a diabetes medical
- 7 management plan for that student to the school. The school
- 8 shall implement the diabetes medical management plan upon
- 9 receipt.
- 10 §302A-D Required care. (a) Any school that has enrolled
- 11 a student who has submitted a diabetes medical management plan
- 12 shall ensure that the student receives the appropriate diabetes
- 13 care specified in the student's diabetes medical management
- 14 plan.
- 15 (b) In accordance with the student's diabetes medical
- 16 management plan, a nurse or trained diabetes care personnel
- 17 shall perform diabetes care, including:
- 18 (1) Checking and recording blood glucose levels and ketone
- 19 levels or assisting a student with diabetes in
- 20 checking and recording blood glucose levels and ketone
- 21 levels;

1	(2)	Responding to blood glucose levels that are outside of
2		the student's target blood glucose range as stated in
3		the student's diabetes medical management plan;
4	(3)	Administering insulin or assisting a student in
5	,	administering insulin via the insulin delivery system
6		that the student uses;
7	(4)	Providing diabetes medicine to be taken orally by the
8		student; and
9	(5)	Facilitating compliance with the recommendations in
10		the student's diabetes medical management plan
11		regarding meals, snacks, and physical activity.
12	(c)	A nurse or trained diabetes care personnel shall be at
13	each scho	ol that has enrolled a student with diabetes during
14	regular s	chool hours, after-school care programs, field trips,
15	extended	off-site excursions, extracurricular activities, and on
16	buses whe	n the bus driver has not completed the necessary
17	training	required under section 302A-B.
18	(d)	Notwithstanding any law to the contrary, the provision
19	of care r	equired under subsection (a) shall not constitute the
20	practice	of nursing. Trained diabetes care personnel who are

not nurses as defined under section 457-2 shall be exempt from

21

- 1 statutory provisions that restrict the activities that may be
- 2 delegated to or performed by a person who is not a licensed or
- 3 registered health care professional to the extent required to
- 4 perform duties pursuant to this part.
- 5 (e) Notwithstanding any law to the contrary, it shall be
- 6 lawful for a licensed health care professional to provide
- 7 training to school employees as required under section 302A-B
- 8 and to supervise trained diabetes care personnel in the
- 9 administration of required care under subsection (a).
- 10 (f) Except for a qualified healthcare professional
- 11 providing the training required in subsection (e), schools,
- 12 nurses, trained diabetes care personnel, and any other person
- 13 acting in good faith and in accordance with the provisions
- 14 established under this part shall not be subject to civil
- 15 liability or to discipline for unprofessional conduct, except
- 16 where the person's conduct would constitute gross negligence,
- 17 wilfull and wanton misconduct, or intentional misconduct.
- 18 §302A-E School assignment; provision of care. (a) A
- 19 student with diabetes shall be permitted to attend any school
- 20 that the student would otherwise be able to attend if the
- 21 student did not have diabetes.

 effectuate this part.
- 3 The report shall be submitted at least twenty days prior to
- 4 the convening of each regular session.
- 5 (b) The department shall adopt rules pursuant to chapter
- 6 91 specifying the criteria for the documentation of the schools'
- 7 compliance with the provisions of this part.
- 8 (c) The department shall publish the district-wide report
- 9 on its website upon submittal to the legislature and the
- 10 governor.
- 11 §302A-H Administrative complaints. (a) An impartial
- 12 hearing before the department may be requested by any parent or
- 13 guardian of a student with diabetes or by a student with
- 14 diabetes for the failure of a school to comply with this part.
- 15 (b) A student with diabetes or the student's parent or
- 16 quardian may bring a lawsuit against the school for failure to
- 17 comply with this part. In the event that the student with
- 18 diabetes or the student's parent or guardian prevails, in
- 19 addition to any judgment awarded, the court may allow reasonable
- 20 attorney's fees and costs of the action to be paid by the
- 21 school.

- 1 (c) Any action brought by a student with diabetes or the
- 2 student's parent or guardian under this part shall not alter or
- 3 limit the remedies available under any other state or federal
- 4 law, including section 504 of the Rehabilitation Act of 1973,
- 5 the Americans with Disabilities Act, and the Individuals with
- 6 Disabilities Education Act of 2004."
- 7 SECTION 3. Within one hundred eighty days of the effective
- 8 date of this Act, the department of education shall adopt rules
- 9 under chapter 91, Hawaii Revised Statutes, to effectuate the
- 10 purpose of this Act.
- 11 SECTION 4. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$ or so much
- 13 thereof as may be necessary for fiscal year 2015-2016 and the
- 14 same sum or so much thereof as may be necessary for fiscal year
- 15 2016-2017 for the department of education to effectuate this
- 16 Act.
- 17 The sums appropriated shall be expended by the department
- 18 of education for the purposes of this Act.
- 19 SECTION 5. There is appropriated out of the general
- 20 revenues of the State of Hawaii the sum of \$ or so much
- 21 thereof as may be necessary for fiscal year 2015-2016 and the

- 1 same sum or so much thereof as may be necessary for fiscal year
- 2 2016-2017 for the department of health to effectuate this Act.
- 3 The sums appropriated shall be expended by the department
- 4 of health for the purposes of this Act.
- 5 SECTION 6. In codifying the new sections added by section
- 6 2 of this Act, the revisor of statutes shall substitute
- 7 appropriate section numbers for the letters used in designating
- 8 the new sections in this Act.
- 9 SECTION 7. This Act shall take effect on July 1, 2112.
