A BILL FOR AN ACT

RELATING TO FOOD WASTE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that waste disposal is an
- 2 issue of critical importance throughout the islands. The
- 3 legislature further finds that even with current statewide
- 4 policies, recycling efforts reduce only a fraction of the solid
- 5 and liquid waste generated. Landfills on all islands are
- 6 approaching or have already reached their maximum capacity, and
- 7 the expansion of current landfills and relocation efforts are
- 8 meeting widespread community opposition.
- 9 Accordingly, the purpose of this Act is to prohibit the use
- 10 of landfills as a means of disposal or transfer for all
- 11 commercial organic material waste.
- 12 SECTION 2. Chapter 342G, Hawaii Revised Statutes, is
- 13 amended by adding a new section to be appropriately designated
- 14 and to read as follows:
- 15 "§342G- Disposal of commercial organic material waste;
- 16 prohibition. (a) Notwithstanding any law to the contrary, any
- 17 generator of commercial organic material shall not dispose of or

- 1 transfer any solid waste to any landfill or waste-to-energy
- 2 facility, or by incineration, in the State.
- 3 (b) Generators of commercial organic material restricted
- 4 by the limitations of subsection (a) shall dispose of or
- 5 transfer all waste rendered by means of donation, compost,
- 6 anaerobic digestion, or animal feed.
- 7 (c) The prohibitions of this section shall not apply to
- 8 special waste or waste created as a result of a natural
- 9 disaster.
- 10 (d) For the purpose of this section, "commercial organic
- 11 material" means any food material and vegetative material from
- 12 any entity that generates more than one ton of those materials
- 13 for solid waste disposal per week, but does not mean any
- 14 material resulting from a residence or centralized dining
- 15 facility."
- 16 SECTION 3. This Act does not affect rights and duties that
- 17 matured, penalties that were incurred, and proceedings that were
- 18 begun before its effective date.
- 19 SECTION 4. New statutory material is underscored.
