A BILL FOR AN ACT

RELATING TO HAWAIIAN LANGUAGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the Hawaiian
2	language college at the University of Hawaii at Hilo requires a
3	broader income base to better fund its operations, services, and
4	outreach program. The Hawaiian language college has established

- 5 the first master's program, first doctoral program, first
- 6 teacher education program, and first preschool through grade
- 7 twelve laboratory school program in Hawaiian or in any Native
- $oldsymbol{8}$ American language. The Hawaiian language support center is the
- 9 primary provider of curriculum materials in the Hawaiian
- 10 language, online materials in the Hawaiian language, in-service
- 11 training through the Hawaiian language, Hawaiian lexicon
- 12 development and dissemination, Hawaiian language American
- 13 Council on the Teaching of Foreign Languages proficiency
- 14 testing, and Hawaiian language medium college courses for high
- 15 school students in the State.
- 16 Annually, the indigenous language outreach program draws
- 17 many visitors from other states and countries. These visitors

- 1 revitalization and the use of indigenous languages in education
- 2 rooted in the science of linguistics. Section 304A-2270, Hawaii
- 3 Revised Statutes, established the Hawaiian language college
- 4 revolving fund to provide funds for the college but only
- 5 provides for deposits into the fund from sales of Hawaiian
- 6 language materials. The Hawaiian language college provides many
- 7 other services and products for which fees are traditionally
- 8 charged, and allowing such fees to be deposited into the
- 9 Hawaiian language college revolving fund would help the Hawaiian
- 10 language college do even more in the field of indigenous
- 11 languages and provide a wider range of services and products.
- 12 The purpose of this Act is to expand the scope of the
- 13 Hawaiian language college revolving fund to allow any funds
- 14 generated by the Hawaiian language college, Hawaiian language
- 15 support center, and indigenous outreach program through fees for
- 16 services, training, and sale of language-related materials to be
- 17 deposited into the revolving fund.
- 18 SECTION 2. Section 304A-2270, Hawaii Revised Statutes, is
- 19 amended to read as follows:
- 20 "[+] §304A-2270[+] Hawaiian language college revolving
- 21 fund. There is established the Hawaiian language college

- 1 revolving fund into which revenues [from the sale of Hawaiian
- 2 language materials generated by the Hawaiian language college,
- 3 Hawaiian language support center, and indigenous outreach
- 4 program through fees for services, training, and the sale of
- 5 language-related materials shall be deposited. Moneys deposited
- 6 into this fund shall be expended to support the Hawaiian
- 7 language college at the University of Hawaii at Hilo established
- 8 under section [+]304A-1301[+]."
- 9 SECTION 3. Statutory material to be repealed is bracketed
- 10 and stricken. New statutory material is underscored.
- 11 SECTION 4. This Act shall take effect on January 1, 2050.
