A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR THE CONSTRUCTION OF AN AIRPORT IN PUNA.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the district of Puna
- 2 needs a new small airport to service residents, particularly
- 3 those living south of the anticipated lava flows. The
- 4 likelihood of lava crossing Highway 130 would result in a large
- 5 part of the Puna district population being cut off from supplies
- 6 and services, which would be detrimental to the community. An
- 7 airstrip could be constructed in less than thirty days, allowing
- 8 for the transportation of supplies and people if the road
- 9 becomes obstructed by the lava.
- 10 Geographically Puna is a huge district, just slightly
- 11 smaller than the island of Kauai. A few factors make access to
- 12 Puna challenging, specifically Puna has an extensive network of
- 13 lava tubes creating terrain that is too risky for the
- 14 construction of roads; therefore, road infrastructure cannot be
- 15 developed to accommodate efficient transportation. The closest
- 16 airport to Puna is Hilo airport, a trip that takes approximately

- 1 six to eight hours round trip from South Puna and requires a
- 2 great amount of fuel. Whether or not Puna is cut off by lava,
- 3 Puna needs an airport in order to more efficiently transport
- 4 supplies.
- 5 Furthermore, Puna is the fastest growing district in the
- 6 county of Hawaii, with a population of 45,326, according to the
- 7 2010 United States census, and is expected to grow to
- 8 approximately 75,000 by 2030. Puna is also becoming
- 9 increasingly popular as a tourist attraction as it is near
- 10 Hawaii Volcanoes National Park and is a world renowned
- 11 destination for ecotourism and personal development
- 12 opportunities.
- 13 The purpose of this Act is to authorize an appropriation
- 14 for construction of a small airport in South Puna.
- 15 SECTION 2. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$ or so
- 17 much thereof as may be necessary for fiscal year 2015-2016 and
- 18 the same sum or so much thereof as may be necessary for fiscal
- 19 year 2016-2017 for construction of a small airport in South Puna
- 20 due to the threat of inaccessibility from lava flow...

- 1 The sums appropriated shall be expended by the department
- 2 of transportation for the purposes of this Act.
- 3 SECTION 3. This Act shall take effect on July 1, 2015.
