A BILL FOR AN ACT

RELATING TO DENTISTRY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the practice of 2 sedation and anesthesia by licensed dentists is regulated by the
- 3 State. However, recent tragedies have led to calls for more
- 4 oversight of the use of sedation and anesthesia by licensed
- 5 dentists. In January 2014, a three-year-old patient died after
- 6 falling into a coma after a dental procedure. It was later
- 7 determined that the dentist had used five different sedatives on
- 8 the young child, who weighed less than fifty pounds. In March
- 9 2014, a twenty-four-year-old woman from Hilo fell into a coma
- 10 while having two wisdom teeth removed.
- 11 Although new sedation rules went into effect last year, the
- 12 legislature concludes that additional oversight for the use of
- 13 sedation and anesthesia by licensed dentists is needed.
- 14 Accordingly, the purpose of this Act is to:
- 15 (1) Specify requirements for the administration of general
- 16 anesthesia and sedation;

1	(2)	Require licensed dentists to possess a written
2		authorization or permit to administer general
3		anesthesia, deep sedation, or moderate (conscious)
4		sedation from the board of dental examiners;
5	(3)	Require the board of dental examiners to establish a
6		process and requirements, including a continuing
7		education component, for the issuance of a written
8		authorization or permit;
9	(4)	Require the board of dental examiners to report to the
10		legislature, no later than twenty days prior to the
11		regular session of 2016, any updates to the written
12		authorization or permit process, including the status
13		of the five year recertification process and
14		continuing education requirements;
15	(5)	Require a report to the board of dental examiners
16		within twenty-four hours of an adverse occurrence
17		during or resulting from anesthesia; and
18	(6)	Specify penalties for failure to report an adverse
19		occurrence.

1	SECTION 2. Chapter 440, nawali Revised Statutes, is
2	amended by adding two new sections to be appropriately
3	designated and to read as follows:
4	"§448- Administration of general anesthesia and
5	sedation; written authorization or permit; recertification. (a
6	No dentist shall administer or employ another person to
7	administer general anesthesia, deep sedation, or moderate
8	(conscious) sedation for dental patients, unless the licensed
9	dentist possesses a written authorization or permit from the
10	board of dental examiners.
11	(b) The board of dental examiners shall review the
12	established process and requirements for the issuance and
13	renewal of a written authorization or permit to administer or
14	employ another person to administer general anesthesia, deep
15	sedation, or moderate (conscious) sedation. The written
16	authorization or permit shall be required every five years, and
17	the requirements for issuance or renewal of a written
18	authorization or permit shall include a continuing education
19	component, to be determined by the board. No later than twenty
20	days prior to the regular session of 2016, the board shall
21	report to the legislature any updates to the written

- 1 authorization or permit process, including the status of the
- 2 five year renewal process and continuing education requirements.
- 3 (c) The board shall issue a written authorization or
- 4 permit to a licensed dentist to use general anesthesia, deep
- 5 sedation, or moderate (conscious) sedation if the licensed
- 6 dentist employs or works in conjunction with a physician who is
- 7 licensed in good standing pursuant to chapter 453 and who is a
- 8 member of the anesthesiology staff of an accredited hospital;
- 9 provided that the anesthesiologist shall remain on the premises
- 10 of the dental facility until the patient is fully recovered and
- 11 discharged from the facility.
- (d) Licensed dentists intending to produce a given level
- 13 of sedation shall have the capability and necessary training to
- 14 rescue patients whose level of sedation becomes deeper than
- 15 initially intended.
- (e) Licensed dentists administering anesthesia shall
- 17 provide twenty-four hour, on-call availability following an
- 18 anesthesia procedure; provided that this section shall not apply
- 19 to procedures using only local anesthetic.
- 20 (f) Dental assistants or technicians shall not administer
- 21 any general or local anesthetic, including intravenous sedation.

2	(a) All	licensed dentists engaged in the practice of dentistry
3	in the St	ate shall submit a report to the board of dental
4	examiners	within twenty-four hours of any mortality or other
5	incident	that results in temporary or permanent physical or
6	mental in	jury requiring hospitalization of a patient during or
7	as a dire	ct result of anesthesia related thereto; provided that
8	if the mo	rtality or other incident occurs on any Friday, or on
9	any Satur	day, Sunday, or legal holiday, the twenty-four hour
10	period sh	all be extended until 4:30 p.m. on the first day
11	following	the weekend or legal holiday.
12	(b)	The report required under subsection (a) shall include
13	at minimu	m responses to the following:
14	(1)	Description of the dental procedure;
15	(2)	Description of the physical condition of the patient,
16		unless the patient has a Class I status as defined by
17		the American Society of Anesthesiologists;
18	(3)	List of drugs and dosage administered;
19	(4)	Detailed description of techniques utilized in
20		administering the drugs utilized;
21	(5)	Doggrintion of the adverse occurrence including.

1	<u>(A)</u>	Symptoms of any complications including but not
2		limited to onset and type of symptoms of the
3		patient;
4	<u>(B)</u>	Treatment instituted on the patient; and
5	(C)	Response of the patient to the treatment; and
6	(6) Desc	ription of the patient's condition on termination
7	of a	ny procedure undertaken.
8	(c) Fail	ure to comply with subsection (a) when the
9	occurrence is	related to the use of general anesthesia, deep
10	sedation, or m	noderate (conscious) sedation shall result in the
11	temporary loss	of the license to practice and disciplinary
12	action by the	board of dental examiners within thirty days."
13	SECTION 3	. New statutory material is underscored.
14	SECTION 4	. This Act shall take effect upon its approval.

Description:

Specifies requirements for the administration of general anesthesia and sedation. Requires licensed dentists to possess a written authorization or permit to administer or employ another person to administer general anesthesia, deep sedation, or moderate (conscious) sedation from the board of dental examiners. Requires the board to review the process and requirements for the issuance and renewal of written authorization or permit. Requires the board to report to the legislature, no later than twenty days prior to the regular session of 2016, any updates to the written authorization or permit process, including the status of the five year renewal process and continuing education requirements. Requires a report to the board of dental examiners within twenty-four hours of an adverse occurrence during or resulting from anesthesia. Specifies penalties for failure to report an adverse occurrence.
