### A BILL FOR AN ACT

RELATING TO EDUCATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the constitutional 2 amendments to article X, section 2, of the Hawaii State 3 Constitution that were adopted by the legislature and ratified 4 by the electorate in the 2010 general election eliminated the election of members to the board of education and now requires 5 6 the governor to nominate and, with the advice and consent of the 7 senate, appoint the members of the board of education. other things, this change was made to hold the governor 8 9 accountable for public education. While by most accounts the 10 new board of education is an improvement and is functioning well 11 overall, some fine-tuning is necessary to truly hold the 12 governor accountable. One consistent complaint from the public 13 about having an appointed board of education is that the board 14 no longer appears to be closely connected to our communities. 15 The legislature further finds that Hawaii is unique in that it is one statewide school district so that the board of 16 17 education is both the state board of education and the local Typically, local school boards are closely 18 school board.

- 3 The purpose of this Act is to reconstitute the board of
- 4 education to ensure that the board of education returns to
- 5 acting as the local school board and reconnects to communities
- 6 and to hold the governor accountable for the governor's

- 3 SECTION 5. The term of office of four existing members of
- 4 the board of education in office as of the day before the
- 5 effective date of this Act, as chosen by the governor, shall
- 6 terminate on June 30, 2015. The term of successor members
- 7 appointed pursuant to this Act and the term of the additional
- 8 at-large member and the additional city and county of Honolulu
- 9 resident member appointed pursuant to this Act shall commence on
- 10 July 1, 2015, and shall terminate on December 31, 2018.
- 11 Subsequent terms shall commence on January 1, 2019, and every
- 12 four years thereafter.
- 13 The term of office of the five members of the board of
- 14 education in office as of the day before the effective date of
- 15 this Act whose terms were not terminated on June 30, 2015, shall
- 16 terminate on June 30, 2016. The term of successor members
- 17 appointed pursuant to this Act shall commence on July 1, 2016,
- 18 and shall terminate on December 31, 2019. Subsequent terms
- 19 shall commence on January 1, 2020, and every four years
- 20 thereafter.

- 1 The appointment by the governor of members to the board of
- 2 education pursuant to this Act shall take place as expeditiously
- 3 as possible so that, to the extent possible, there are no
- 4 vacancies in the membership of the board as of July 1, 2015.
- 5 SECTION 6. Statutory material to be repealed is bracketed
- 6 and stricken. New statutory material is underscored.
- 7 SECTION 7. This Act shall take effect on June 30, 2015.

### Report Title:

Board of Education; Membership; Terms of Office

#### Description:

Reconstitutes the board of education to consist of eleven rather than nine members, one each from the seven department of education districts (Hawaii, Maui, Kauai, Honolulu, Central, Leeward, and Windward), and four at-large members. Requires that at least one at-large member be from a neighbor island, at least two at-large members have business management experience, and at least two members have public education experience; provided that one member have experience as a school principal or vice principal. Increases the number of nonvoting public high school representatives to the board from one to two students. Increases the term of office for members of the board of education from three to four years, staggers terms with six members' terms beginning January 1 following a gubernatorial election year, and five members' terms beginning the following January 1. Eliminates term limits. Terminates the membership of the current board on June 30, 2015. Effective 6/30/15. (SD1)
