# A BILL FOR AN ACT

RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 88, Hawaii Revised Statutes, is amended 2 by adding a new section to subpart C of part II to be 3 appropriately designated and to read as follows: 4 "\$88- Forfeiture of benefits; felony convictions. (a) 5 If a member, former member, or retirant is convicted of a felony and the court finds that, by a preponderance of the evidence, 6 7 the felony is related to the employment of the member, former 8 member, or retirant by the State or any county, the court may 9 decree a civil penalty, pursuant to section 706-605(8), of 10 forfeiture by the member, former member, or retirant of all or a 11 portion of any: 12 (1) Interest; 13 (2) Hypothetical account balance in excess of the amount 14 representing any employee contributions made by or on 15 behalf of the member, former member, or retirant; (3) 16 Pension; 17 (4)Annuity; or

- 1 to which the member, former member, or retirant may otherwise be
- 2 entitled under this chapter; provided that upon the death of the
- 3 member, former member, or retirant, the designated beneficiary
- 4 of the member, former member, or retirant may receive benefits
- 5 to which such beneficiary would otherwise be entitled under this
- 6 chapter.
- 7 (b) Upon receipt of a certified copy of the order
- 8 decreeing forfeiture, the system shall comply with the order and
- 9 shall reduce, suspend, or deny payment to the member, former
- 10 member, or retirant as provided in the order until such time as
- 11 the system receives a certified order to:
- 12 (1) Increase, resume, or make payments to the member,
- former member, or retirant; or
- 14 (2) Quash or reverse the decree of forfeiture.
- 15 The system shall not be required to make inquiry into the
- 16 propriety of the order decreeing forfeiture or recoup any
- 17 payments made to the member, former member, or retirant prior to
- 18 receipt by the system of the order decreeing forfeiture.
- (c) For the purposes of this section, a felony is "related
- 20 to the employment" of an employee of the State or a county if

3	(1)	Felonies in which state or county time, equipment, or
4		other facilities are used in the commission of the

6	(2)	Bribery;
7	(3)	Embezzlement, theft, or other unlawful taking,
8		receiving, retaining, or failing to account properly
9		for, any property or funds that belong to the State or
10		any county or any department, bureau, board, or other
11		agency thereof; or
12	(4)	A felony committed against a person over whom the
13		employee, in the course of the employee's duties,
14		exercises custody or supervision.
15	(d)	This section shall not impair or diminish benefits
16	accrued prior to the effective date of this section. This	
17	section sl	hall not apply to felonies committed prior to the
18	effective	date of this section.
19	(e)	This section shall not apply to accrued retirement
20	benefits t	that are non-forfeitable pursuant to sections 88-73(f),
21	88-281(g)	, and 88-331(f)."

## Report Title:

Employees' Retirement System; Retirement Benefits; Felony Convictions; Forfeiture

#### Description:

Allows the court to decree a forfeiture by the member, former member, or retirant of all or a portion of any interest, hypothetical account balance (in excess of the amount representing any employee contributions made by or on behalf of the member, former member, or retirant), pension, annuity, or retirement allowance that the member, former member, or retirant may otherwise be entitled to if a member, former member, or retirant is convicted of a felony and the court finds that the felony is related to the employment of the member, former member, or retirant by the State or any county. Requires the employees' retirement system to comply with the court order and suspend or deny payment to the member, former member, or retirant as provided in the order. Effective date 1/7/2059. (SD2)
