A BILL FOR AN ACT

RELATING TO AQUARIUM FISH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that cruelty to pet
- 2 animals including dogs, cats, guinea pigs, and caged birds, in
- 3 Hawaii, is a misdemeanor. Hawaii's animal cruelty laws reflect
- 4 Hawaiian values of living in harmony and balance with nature,
- 5 respect and responsibility for the surrounding environment, and
- 6 ethical treatment of animals.
- 7 The legislature further finds that reef species captured
- 8 and sold as pet animals are subject to cruel and unethical
- 9 treatment, including mutilation, puncturing, and confinement,
- 10 which are common practices by individuals capturing and selling
- 11 these species.
- 12 The legislature finds that such cruel and unethical
- 13 practices are incompatible with Hawaii's local values, and
- 14 existing laws do not provide adequate protection from cruel
- 15 treatment.
- 16 The purpose of this Act is to increase survivability and
- 17 prohibit the cruel and unethical treatment of Hawaii's marine
