A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The Children's Advocacy Centers of Illinois,
- 2 Illinois Coalition Against Sexual Assault, and Prevent Child
- 3 Abuse Illinois collaborated to create "Erin's law". Erin Merryn
- 4 was raped and molested for six and a half years by a neighbor
- 5 and a family member. Erin began a crusade her senior year of
- 6 high school in 2004 to end the silence and shame around sexual
- 7 abuse. Erin's Law has been passed in seven states with more
- 8 than ten states introducing it. Erin's mission is to shatter
- 9 the silence and stigma around sexual abuse, and to educate
- 10 children and empower them to recognize and to report abuse.
- 11 The legislature finds that schools fail to give young
- 12 students awareness and a voice if someone is violating them.
- 13 Unfortunately without being educated most children will be
- 14 repeatedly abused for years because often the only message they
- 15 get comes from their abuser threatening them into silence.

1	The purpose of this Act is to educate public school		
2	students on sexual abuse prevention through an age appropriate		
3	curriculum.		
4	SECTION 2. Chapter 302A, Hawaii Revised Statutes, is		
5	amended by adding a new section to part II, subpart B, to be		
6	appropriately designated and to read as follows:		
7	"§302A- Sexual abuse prevention instructional program;		
8	guidelines.	(a) The broad guidelines of the sexual abuse	
9	prevention instructional program shall be to:		
10	<u>(1)</u> Educ	cate children in grades pre-kindergarten through	
11	twel	ve in public schools on sexual abuse prevention	
12	thro	ough age appropriate curriculum through role plays,	
13	disc	cussions, activities, and books;	
14	<u>(2)</u> <u>Give</u>	e children the tools to speak up and tell if anyone	
15	has	ever touched them inappropriately rather than keep	
16	<u>it a</u>	a secret; and	
17	<u>(3)</u> <u>Educ</u>	cate children on safe touch, unsafe touch, safe	
18	seci	cets, and unsafe secrets, how to get away and	
19	repo	ort an incident immediately.	
20	(b) All	public schools shall establish a sexual abuse	
21	prevention ins	structional program for students in grades	

1	pre-kindergarten through twelve, consistent with subsection (a).		
2	The content of instruction shall be at the discretion of the		
3	board; provided that at minimum, the instruction shall include:		
4	(1)	Techniques to teach children to recognize child sexual	
5		abuse, equip them with skills to reduce their	
6		vulnerability, and encourage them to report the abuse;	
7	(2)	At least four sessions of instruction to reinforce the	
8		concepts learned in the program;	
9	(3)	Sessions conducted at least annually, building on	
10		skills learned the previous year;	
11	(4)	Developmentally appropriate instruction for each grade	
12		<pre>level;</pre>	
13	(5)	Involvement of students as active learning	
14		participants, and include discussions, modeling, and	
15		role playing;	
16	<u>(6)</u>	A capacity to be delivered by a wide range of	
17		personnel and professionals, including teachers,	
18		school counselors, outside agency prevention	
19		educators, and the like; provided that the personnel	
20		and professionals should have a thorough knowledge of	

1		child sexual abuse, including how to respond
2		appropriately to sexual abuse disclosures;
3	(7)	An evaluation component with measurable outcomes;
4	(8)	Instruction that is culturally sensitive and adaptable
5		for use within varying school contexts, including age,
6		race, and special needs;
7	(9)	An evidence-based curriculum, to the extent possible;
8	(10)	A professional training component for administrators,
9		teachers, and other school personnel on talking to
10		students about child sexual abuse prevention, effects
11		of child sexual abuse on children, handling of sexual
12		abuse disclosures, and mandated reporting; and
13	(11)	A component that encourages parental involvement
14		within the child sexual abuse prevention program.
15		This component should inform parents about child
16		sexual abuse topics, including characteristics of
17		offenders, grooming behaviors, and how to discuss this
18		topic with children."
19	SECT	ION 3. New statutory material is underscored.
